With the advent of America Online, I began helping people on its message boards and chats. I found it so rewarding that I closed my law firm and moved to Seattle to found PrairieLaw.com, a virtual law community, later the lion's share of lawyers.com when acquired by LexisNexis.

I bumped into a blog as a way to teach lawyers how to develop business on the Internet. Not through websites and distributing information alone, but by connecting with people in a real and authentic way so as to build a name, relationships and trust.
