SUPER BOWL GAMBLING REMINDER



Super Bowl Gambling Reminder









As a student-athlete, coach, or institutional staff member with the University of Cincinnati Athletics, you <u>CANNOT</u> engage in any gambling activities related to <u>the</u>

Super Bowl or any other sport that has a NCAA Championship.

- With the Super Bowl approaching on February 13, this is a reminder that all studentathletes, coaches, and staff are not permitted to wager on the game or any other sport that has a NCAA-sponsored championship
- This includes any prop bets, such as the length of the national anthem, the winner of the coin flip, and the color of Gatorade poured on the winning coach.

10.3 Sports Wagering Activities. The following individuals shall not knowingly participate in sports wagering activities or provide information to individuals involved in or associated with any type of sports wagering activities concerning intercollegiate, amateur or professional athletics competition: (Adopted: 4/26/07 effective 8/1/07, Revised: 1/22/20)

- (a) Staff members of an institution's athletics department;
- (b) Nonathletics department staff members who have responsibilities within or over the athletics department (e.g., chancellor or president, faculty athletics representative, individual to whom athletics reports);
- (c) Staff members of a conference office; and
- (d) Student-athletes.

10.3.1 Scope of Application. [#] The prohibition against sports wagering applies to any institutional practice or any competition (intercollegiate, amateur or professional) in a sport in which the Association conducts championship competition, in bowl subdivision football and in emerging sports for women. (Adopted: 4/26/07 effective 8/1/07)

YOUNGSTOWN STATE INFRACTIONS

- The former women's soccer head coach falsified transcripts for three international student-athletes. The coach arranged for false transcripts to show that the student-athletes attended a university in their home country that they never did so they would be immediately eligible for competition and financial aid.
- The coach also arranged for another student to pay for one prospect's application fee, arranged cost-free summer housing, and provided transportation to that housing and campus prior to enrollment for that prospect. The three student-athletes competed in 61 competitions while ineligible.

PENALTIES

- Three years of probation
- Postseason ban for 2019-20 and vacation of records in which student-athletes competed while inelgibile.
- Scholarship reduction by one equivalency for 2020-21
- · Reduction in official visits by 5 during
- 10-week ban on unofficial visits, recruiting communications, and off-campus recruiting during one academic year in the probation period
- Five-year show-cause order for the former head coach. If hired after the show-cause order has ended, the coach is suspended form the first 50% of contests in their first season.
