### Is this Permissible

Scenario: Coach's team is currently out of season, so when they return to campus, they are not in their 20 hours. Coach wants to hold 6 mandatory 1.25 hour practice sessions and one 30 minute meeting between Monday through Saturday during their 8 hour week. The athletes would have Sunday off. Does this practice schedule work?

Answer: No, this schedule does not work, because out-of-season student athletes are required to have two mandatory days off each week. Only one mandatory day off is required when the team is in-season.

**17.1.7.5 Required Days Off -- Outside of the Playing Season.** Outside of the playing season during the academic year, all countable athletically related activities (per Bylaw 17.02.1) are prohibited during two calendar days per week. (*Adopted: 4/29/04 effective 8/1/04*)

### TENNESSEE FOOTBALL RECRUITING SCANDAL

On Friday July 22, the NCAA gave University of Tennessee a list of 18 violations and findings of almost \$60,000 of cash or gifts provided to players and their families.

- The NCAA found these violations occurred from 2018-2021 during former Head
   Coach Jeremy Pruitt's tenure
- The allegations accuse Pruitt, his wife, numerous coaches, recruiting staff, and at least one booster
- Each of the 18 violations are level 1 which is the most severe level the NCAA has
  - Tennessee has 90 days to respond to the findings with their self-sanctioned penalties and after that the NCAA has 60 days to add additional penalties
