SUMMER CAMP EMPLOYMENT

- A SA may be employed by their institution, by another institution, or by a private organization to work a camp or clinic as a counselor, unless otherwise restricted by NCAA legislation.
- The student-athlete must be paid the going rate for camp employees of like teaching ability and experience. A student-athlete who only lectures or demonstrates at a camp/clinic may not receive compensation for an appearance at the camp/clinic
- PSAs can be employed at institutional camps or clinics, provided they have signed an NLI and/or a written offer of admission/financial aid, or the institution has received the PSA's financial deposit in response to its offer of admission.
- All employees participating in Camp must turn in the proper paperwork (background check and Form1 / Form 2) as well as complete the educational module.

Is this Permissible

Coach Wright sees one of his student athletes post a picture on Twitter of their summer workout. It is during the summer vacation period, and he is so proud to see the student athlete putting in extra work out of season. He wants to let the student athlete know he appreciates all their hard work and 'favorites' the tweet. He also responds to the photo, telling the student athlete to keep up the good work.

No, this is not permissible. Coaches MAY NOT promote voluntary workouts that their student athletes post on social media. This includes liking or commenting on any posts. Taking an action of approval is a prohibited form of reporting and recognition.

University of Nebraska Infractions

- •Nebraska was found to be in violation of NCAA rules that limit the number of coaches permitted to work with players during practices and games. The violation involved their former special team's analyst who, "provided technical or tactical instruction to student-athletes during practices and film sessions" and assisted in tactical decisions during games.
- •The penalties are classified as Level II on the three-plane NCAA structure, "a significant breach of conduct" that can include failure to monitor but do not involve lack of institutional control.

Penalties:

- Probation: A one-year extension of the existing probationary period to conclude April 27, 2023
- •A fine of \$10,000 to the NCAA
- •The head football coach shall be subject to a one-year show-cause order and five-day suspension from all coaching duties during the upcoming football season. He also received a letter of admonishment.
- •All noncoaching staff members shall be removed from practice and competition for five consecutive days during the championship segment of the 2022 season
- •A reduction in the number of countable coaches by one for two days of practice (eight hours total) during the spring 22
