## ***News Headlines***

### ***Lawsuit Filed Against University of Kansas football player***

The University of Kansas football program is currently under fire after a lawsuit was filed against a player who allegedly sexually assaulted a member of the rowing team. Daisy Tackett, a former varsity rower at KU, reported that a member of the football team raped her during a party at one of the university-owned dorms back in 2014. Sexual assault has become a key topic of interest at U.S. colleges as countless reports have been documented regarding violence and sexual violence. Although KU is not the first school to have been involved in a sexual assault case, they are ultimately responsible for the actions taken by students and athletes. Tackett, who left KU before graduating, came forward with the allegations after learning that the same Jayhawk football player attempted to assault one of her rowing teammates. The investigation and lawsuit is on-going. If any wrong doing is found, punishments could be handed down to both the football player and the KU Athletic Department.



### ***Investigation into Academic Fraud at UNC Continues***

As the University of North Carolina Tar Heels prepare to head to Houston for their 19th Final Four appearance in school history, they continue to face investigation for academic fraud. NCAA president Mark Emmert continues to pursue allegations that UNC committed academic improprieties from 1993-2011. These allegations involved athletes from many different sports at UNC. With the men's basketball team set to play Syracuse in the Final Four, the investigation and potential penalties will have to wait. UNC could face harsh penalties or could self-impose a postseason ban for their sports teams during the 2016-2017 academic year. Until then, UNC will pursue its' sixth NCAA championship at the Final Four, where they will face the winner of the Villanova/Oklahoma semi-final if they beat Syracuse.

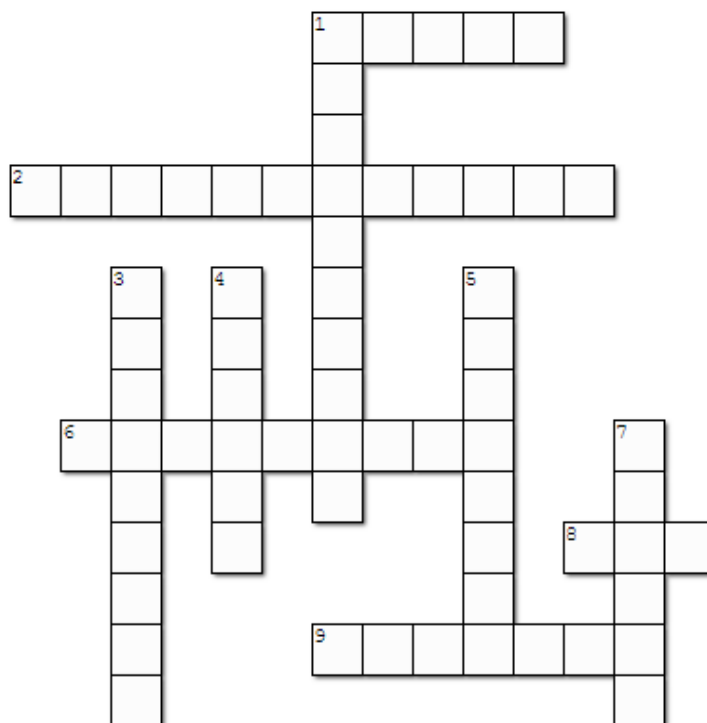

# Knott Wright University Question of the Month

True or false: When submitting a hardship waiver, the medical documentation that establishes the student-athlete's inability to participate due to illness or injury does not have to come from the physician that administered care to the student-athlete.

**Answer: False.** Bylaw 12.8.4.3.3 states that contemporaneous or other appropriate medical documentation, from a physician (a medical doctor) who administered care at the time of the injury or illness, that establishes the student-athlete's inability to compete as a result of that injury or illness shall be submitted with any hardship-waiver request. (*Adopted: 4/20/99, Revised: 2/22/01, 7/31/14*)



## *Tip of the Month-Track Your Alumni*

As we move towards the end of the academic year, make sure you roll your seniors over to Alumni status. This way you will be able to keep them up to date on your program in the same manner you can communicate with current student-athletes (i.e. via mass email).

Log into JF and along the top go to DATABASES and then STUDENTATHLETES.

- 1.) Make sure the status along the top is set to CURRENT ROSTER.
- 2.) Select those seniors that you want to keep in contact with as alumni by checking the box on the very left hand column.
- 3.) Once selected, click the CONVERT TO ALUMNI button above the column headings.
- 4.) Confirm that you are ready to archive them as Alumni by clicking YES.
- 5.) You now will find your newly created alumni list if you go to DATABASES and then OTHER CONTACTS.

You can even track their contact information and their donations to your program by clicking on their name and entering this information. If you have a long list of Alumni already send it to support@jumpforward.com and they will add them to this database for you.
