FOCUS OF THE MONTH

RECRUITING UPDATES AND REMINDERS

- The COVID-19 temporary dead period is ending on May 31, and normal recruiting calendars are returning. Please see the bottom of the second page for each sport's June calendar.
- Some changes from the COVID Q&A guide are remaining
 - It is permissible for student-athletes to participate in recruiting calls.
 - It is permissible for any staff member that has passed the recruiting exam to initiate or participate on calls with PSAs.
 - Committed PSAs are permitted to participate in virtual team activities once they have hraduated high school or finished their academic year for transfers.
 - Uncommitted PSAs may observe virtual team activities one time per PSA through the summer of 2021.
- Official and unofficial visits can also begin on June 1. The forms for those visits are in ARMS.
- Requirements for Official Visits
 - Registered with the EC, activated on our IRL, and they must send UC an academic transcript.

UPDATES AND REMINDERS

- The 2021-22 Coaches Exam is live. We are offering tests on the following dates in person: 6/2, 6/16, 6/30, 7/14, and 7/30, and virtually on: 6/9, 6/23, and 7/21. Please schedule a date and time with your compliance officer.
- The NCAA approved a blanket waiver that once again permits virtual non-physical CARA this summer for up to 8 hours a week. Incoming PSAs may participate as long as they have finished all high school and transfer academic requirements.

SPOT THE VIOLATION

Samantha Gamgee is a women's soccer student-athlete at Rivendell University. During the summer vacation period, she reaches out to the team's strength and conditioning coach and asks the coach if she could design some workouts for her and conduct them as well. After the training session, the strength coach runs into the women's soccer head coach. During their conversation, the strength coach mentions that she just put Samantha through a workout, but doesn't mention the type of workout or the results. Spot the violation.

It is impermissible for the strength coach to report any information about a voliuntary activity to a coach, including the names of the student-athletes that participated. It is permissible for the strength coach to design and conduct the workout since the student-athlete requested the workout.
