FSU NIL INFRACTIONS CASE

- FSU Assistant Football coach facilitated an impermissible recruiting contact between a transfer prospect and a booster
- During an official visits, the assistant coach arranged for the PSA and his parents to be transported to and from campus to meet with a booster and the CEO of an FSU Collective
- The booster encouraged the PSA to enroll at FSU offering him \$15,000 per month for his first year of enrollment
- The FSU Program Penalties include:
 - 2-years of probation
 - A 2-year show cause order for the assistant coach and a suspension from the next 3 regular season games, a two-week restriction on recruiting communication, and required attendance at an NCAA Regional Rules Seminar
 - A restriction on off-campus recruiting for the fall of 2023
 - A 3-year disassociation with the booster
 - A 1-year disassociation with the collective
 - A reduction of 5 football scholarships for two years
 - \$5,000 fine and 1% of the FSU football budget
 - A reduction in allowable official visits, recruiting communications, and inperson recruiting days

SUPER BOWL GAMBLING REMINDER

You MAY NOT bet on the Super Bowl!

The NCAA prohibits sports wagering on <u>ANY</u> NCAA Sponsored Sports at the amateur, intercollegiate or professional level.

Sports Wagering can result in loss a season of eligibility and up to all of your remaining eligibility if you are a student athletes, and employment if you are an employee!

IS THIS PERMISSIBLE?

PSA is coming on an <u>unofficial</u> visit with his mom and dad. PSA also has a younger sibling who is 10, who is unable to stay home alone during the visit. Can we as an institution provide PSAs younger sibling with a complimentary ticket?

- A. No, because you may only provide 3 complimentary tickets for unofficial visits.
- B. Yes, because you can provide a four complimentary tickets on unofficial visits, just like official visits.
- C. No, because the PSAs sibling is not old enough to come on an unofficial visit
- D. Yes, because the sibling isn't old enough to stay home, we can provide the PSAs family an extra ticket

Answer: A No, because you may only provide 3 complimentary tickets for unofficial visits.

The PSAs family would be able to buy an additional ticket, so they can all attend the game together.

13.7.3.1 General Restrictions. [A] During an unofficial visit, the institution may not pay any expenses or provide any entertainment except a maximum of three complimentary admissions (issued through digital ticketing or a pass list) to a home athletics event at any facility within a 30-mile radius of a member institution's main campus in which the institution's intercollegiate team practices or competes. Such complimentary admissions are for the exclusive use of the prospective student-athlete and those persons accompanying the prospective student-athlete on the visit and must be issued on an individual-game basis. Such admissions may provide seating only in the general seating area of the facility used for conducting the event. Providing seating during the conduct of the event (including intermission) for the prospective student-athlete or those accompanying the prospective student-athlete in the facility's press box, special seating box(es) or bench area is specifically prohibited. Complimentary admissions may not be provided during a dead period, except as provided in Bylaw 13.7.3.5.
