<u>Summitt Steps Down at Louisiana Tech after having inappropriate relationship with player</u>

Tyler Summitt has resigned from his position as head coach at Louisiana Tech. Summitt stepped down as the head coach of the women's basketball team after he admitted to having an affair with one of his players. Summitt is the son of the legendary Pat Summitt, who coached the Lady Vols at the University of Tennessee from 1974-2012 and won 8 NCAA championships. After spending time as an assistant coach for his mother at Tennessee, Summitt moved on to Marquette, where he met Brooke Pumroy. Pumroy is the woman at the center of the affair. According to news sources, Summitt started an affair with Pumroy when they were both at Marquette. When Summitt was hired at Louisiana Tech, he brought Pumroy in to be a part of the program. Pumroy is a senior guard from Fairborn, Ohio. There is speculation that she is now pregnant by Summitt. Summitt, who's married to his high school sweetheart, spent 2 seasons as head coach at Louisiana Tech with an overall record of 30-31.



<u>University of California reaches settlement in</u> wrongful-death lawsuit

The University of California reached a settlement with the family of Ted Agu, who died after a team drill with the Cal football team. Agu, who carried a sickle cell trait, was a defensive lineman on the team and a pre-med student at the school. The family sued the university for liability since they were aware that Agu carried the sickle cell trait and put him in a compromising position. Agu was participating in an off-season summer conditioning workout. The university admitted liability in the lawsuit and agreed to pay \$4.75 million in damages to Agu's family. There will also be changes made to the way coaches and trainers can use high physical activity to discipline players. Cal coaches were having players run intense drills when Agu collapsed from exhaustion. Coaches will also receive more education on the sickle cell traits and medical conditions that can result from it.

Yes., with conditions. NCAA Bylaw 11.3.2.3 states that an institution may permit an outside individual, group or agency to supplement an athletics department staff member's salary with a direct cash payment in recognition of a specific and extraordinary achievement (e.g., contribution during career to the athletics department of the institution, winning a conference or national championship, number of games or meets won during career/season), provided such a cash supplement is in recognition of a specific achievement and is in conformance with institutional policy.

Via Email to Support:

- Attach the pictures you would like to use and any other graphic you would like to include to give the graphics design team as much information as possible.

Via the Support Tab:

- 1. Login to JF and along the top hover over SUPPORT.
- 2. Click on REQUEST NEW GRAPHIC.
- 3. Complete the form as completely as possible in order to give the graphics design team as much information as possible.
