FOCUS OF THE MONTH

UNDERGRADUATE FOUR-YEAR TRANSFER PROCESS

Effective for 2023-2024 championship eligibility the NCAA has stated that an undergraduate transfer waiver will only be considered for student-athletes who transfer:

- For reasons related to the student-athlete's physical or mental health and wellbeing.
- Due to exigent circumstances outside the student-athlete's control (e.g., physical or sexual assault or discrimination based on a protected class); or
- Assertions involving diagnosed education impacting disabilities

Reasons an undergraduate transfer waiver will be denied

	Academic Reasons	Athletic Reasons
1)	Degree program does not meet SA's expectations (e.g., academic difficulty).	 Lack or change of participation: No participation opportunity. Reduction in playing time. Change in position or role on the team.
2)	Perceived prestige of an institution's degree program does not meet SA's expectations.	Change to athletics scholarship.
3)	SA transferred to change majors	Coaching change

EXAM WEEK REMINDER

Exam Week (Saturday, April 22nd - Thursday, April 27th):

Yes with conditions.

Division I NCAA Bylaw 14.2.1.7 states that in sports other than football, a former student (e.g., former student-athlete) at the certifying institution may participate in an organized practice session on an occasional basis, provided the institution does not publicize the participation of the former student at any time before the practice session. (Adopted: 3/3/11, Revised: 4/25/18 effective 8/1/18)
