(NCAA Bylaw 10.3)

#### Bylaw 10.3.1

The prohibition against sports wagering applies to any institutional practice or competition (intercollegiate, amateur, or professional) *in a sport in which the Association conducts championship competition*, in bowl subdivision football and in emerging sports for women.

#### Bylaw 10.3.2

The following sanctions for violations of Bylaw 10.3 shall apply:

- A student-athlete who engages in activities designed to influence the outcome of an intercollegiate contest or in an effort to affect win-loss margins ("point-shaving") or who participates in any sports wagering activity involving the student-athlete's institution shall permanently lose all remaining regular-season and postseason eligibility in all sports.
- A student-athlete who participates in any sports wagering activity through the Internet, a bookmaker or a parlay card shall be ineligible for all regular-season and postseason competition for a minimum of a period of one year from the date of the institution's determination that a violation occurred and shall be charged with the loss of a minimum of one season of eligibility. If the student-athlete is determined to have been involved in a later violation of any portion of Bylaw 10.3, the student-athlete shall permanently lose all remaining regular-season and postseason eligibility in all sports.

## **Pop Some Tags**

# **Knott Wright University Question of the Month**

Which of the following may <u>NOT</u> be provided by an institution to a student host during an official visit by a prospective student-athlete?

- A. \$40 per day to the student host to cover all actual entertainment costs
- B. An additional \$25 per day for entertainment costs for each additional prospect on the visit
- C. Complimentary meals, provided that the student host accompanies the prospective student-athlete
- D. Complimentary admission to UC athletics events, as long as the student host goes with the prospect

ANSWER: B. Institutions may only provide \$20 per day per additional prospect to a student host, not \$25 (see NCAA Bylaw 13.6.7.5(a)).

# **News Headlines**

#### Orange is the new blue

Syracuse Men's Basketball announces self-imposed postseason ban for 2015

The Syracuse University Orange men's basketball team will be staying home for this year's postseason after the university self-imposed a ban in response to an ongoing NCAA investigation into past wrongdoing. The ban prohibits participation in the NCAA and ACC tournaments, as well as the NIT.

Syracuse has been under investigation since 2007 when it self-reported possible NCAA violations in its football and basketball programs. School officials said that none of the conduct being investigated involves current players.

#### More trouble in paradise

University of Hawaii receives official Notice of Allegations from the NCAA

University of Hawaii received a 42 page Notice of Allegations. The Notice alleged seven NCAA violations, including three Level I and four Level II violations, the two most serious levels of violations.

Allegations include impermissible tryouts during official visits, extra benefits, dishonest conduct, and using operations personnel as coaches. Two former coaches are also charged with obstructing an investigation, providing an iPad to a studentathlete, and falsifying a student's admissions documents.
