FOCUS OF THE MONTH

FINAL EXAM CARA REMINDERS

- Final Exams begin Saturday April 23rd and continue Thursday April 28th. For out-of-season sports, CARA and RARA are prohibited one week prior to the beginning of exams through the end of the academic term (4/16-4/28/22).
- Daily and weekly CARA limitations still apply for in-season sports during the final exam period.
- Student-athletes outside of the playing season cannot participate in any CARA during the summer vacation period.
- Strength coaches may design and conduct specific workout programs for a student-athlete, provided the workouts are voluntary and conducted at the student-athlete's request.

OTHER SUMMER REMINDERS

- Student-athletes that plan on having a summer job must fill out an Employment Form.
- Student-athletes that are planning on competing in outside competition over the summer must fill out an Outside Competition Log.
- Student-athletes must complete the Summer Contract Information Form to be contacted in case of eventual drug testing.
- Student-athletes in individual sports may ask their coaches to perform voluntary workouts during the summer period.

SPOT THE VIOLATION

LS High School has 2 of the top 10 recruits in the state of Ohio in Men's Basketball. The head coach at MBU has been heavily recruiting both players and the school has been lucky enough to be mentioned as one of the top 5 schools for each recruit. The head coach is wanting to get a leg up on the other schools to secure the commitment of both of the prospects, so he decides on Monday that he wants to contact the PSAs at their high school. When the coach arrives at the institution on Monday, he meets with one of the PSAs, but finds out that the other PSA missed school that day due to being sick. The coach says, "no worries" and states he will return later in the week when the second PSA returns to class. The head coach then comes back on the Thursday of that same week and meets with the second PSA who had previously missed school when the coach came on his first visit to LS High School. Is what the head coach did permissible? If not, where did the violation occur?

The head coach of MBU committed a violation when he visited LS High School twice in the same week. **13.1.4.1 Men's Basketball.** In men's basketball, institutional staff members may visit a prospective student-athlete's educational institution on not more than one calendar day during a particular week within a recruiting period that occurs during the academic year, regardless of the number of prospective student-athletes enrolled in the institution or whether any prospective student-athlete is contacted on that day.
