FOCUS OF THE MONTH

NIL GO DEAL FLOW REPORT

Since NIL GO launched on June 11, 2025, and through August 31, 2025:

- 28,342 student-athletes and 1,227 institutional users have registered and are approved to use the NIL GO platform.
- 3,160 designated representatives/agents have been added by student-athletes.
- Since launch, 1,658 student-athletes and 507 institutional users have logged into NIL GO during an average week.
- 6,090 deals have been cleared, with values ranging up to \$1.6M+.
- The total value of deals in the NIL GO system to date is \$79.8M.
- The total value of cleared deals to date is \$35.42M.

FRESNO STATE, SAN JOSE STATE GAMBLING FINDINGS

The NCAA released the findings of their investigation into the Fresno State and San Jose State basketball betting violations.

- Three men's basketball players made coordinated efforts to bet on their own games, each other's games, and provided information to the others during the 24-25 season. Two were found to have manipulated their own performances to ensure the bets were won. All are no longer enrolled at the institutions.
- The NCAA has deemed these athletes permanently ineligible. They can only be reinstated with assistance from an NCAA-member school.

IS THIS PERMISSIBLE?

The Bearcat State University (BSU) football team is playing a home game this weekend against its biggest rival, and tickets have been sold out for weeks. Jet Sweep, a football student-athlete at BSU received four complimentary admissions to the game. Unfortunately, none of his friends can come to his game, so Jet decides to trade the four tickets with another BSU student who will give Jet concert tickets. Is this permissible?

PERMISSIBLE?

NO! Under NCAA Bylaw 16.2.2.1, a student-athlete may not receive payment of any source for complimentary admissions and may not be exchanged for any value.

MYTH BUSTERS

The development staff at Bearcat State University plan to reach out to new donors to request that they make donations to third-party NIL entities. To incentivize the donors to make donations, the BSU development staff plans to offer season men's basketball season tickets to the donors.

MYTH BUSTED!

Based on the 2025 House Settlement decision, institutions cannot provide assets to a donor as an incentive to provide funding to NIL entities.
