# Women In Government Legislator Travel Scholarship Policy Leadership & Innovation Summit-San Antonio, TX

Women In Government is pleased to offer travel assistance to attend our national conferences to women state legislators who are currently serving in state legislature in 2023 and will be serving in state legislature in 2024. A Legislator Travel Scholarship of up to \$1150 for WIG's Leadership & Innovation Summit in San Antonio, Texas November 2-5, 2023 is available on a first-come/first-served basis to registered women state legislator attendees (i.e., those who have paid the \$150 registration fee) to reimburse personal travel expenses. Reimbursable travel expenses include: airfare/train or mileage to the host city, ground transportation to the host hotel, and sleeping room accommodations (room + tax only) during conference nights only (11/1, 11/2, 11/3, and 11/4). Food and beverage expenses (whether during travel or outside of meals that WIG provides as part of our conference agenda), cash tips to housekeeping or other staff or service providers are not reimbursable expenses under this Travel Scholarship Policy.

Legislator attendees are responsible for arranging all travel to and from the conference site including reserving a room at the host hotel or offsite. A unique link and/or phone number is provided as part of the registration process to make a reservation within Women In Government's room block at the host hotel prior to the room block deadline of Monday, October 9, 2023. If you need to cancel or change your flight or hotel reservation for any reason, you are responsible for notifying your airline and/or the hotel.

Participants are accountable to attend <u>all</u> sessions and conference events in order to receive the Legislator Travel Scholarship. Late arrival or early departure without receiving prior approval from WIG's Executive Director will result in a reduction of the travel scholarship award. All attendees agree to abide by all health and safety rules of the conference venue/s and jurisdiction/s in addition to abiding by Women In Government's Code of Conduct Policy. Failure to comply with health and safety rules or WIG's Code of Conduct may result in reduction of the Legislator Travel Scholarship reimbursement award.

All reimbursements are issued post-conference. To receive reimbursement, legislator awardees must fill out a Legislator Travel Reimbursement Form (available approximately one week before the conference, as well as onsite) that includes a <u>complete</u> mailing address, signature acknowledging that the legislator attendee is not eligible for travel reimbursement from their state, and all accompanying receipts. This completed form and all receipts must be returned to Women In Government (by mail or email) no later than 45 days after the conclusion of the conference, by Friday, December 22, 2023.

## **Cancellation Policy:**

If you need to cancel your registrations, please notify Women In Government immediately if you are unable to attend so that we may award your scholarship to another legislator. Registration fee may be refunded as follows:

- 100% of the registration fee is refunded for cancellation made by 9/21/2023
- \$100 of the registration fee is refunded for cancellations received from 9/22-10/25/2025
- After 10/26/2023, no registration fee is refunded, but registrants may apply the paid registration fee towards a 2024 conference (please contact staff for details)
- Registrants who transferred credit from the 2023 National Legislative Conference-Annapolis but cannot attend the Leadership & Innovation Summit-San Antonio and will not be serving in legislature in 2024 will be refunded 100% of the registration fee.
- Attendees cancelling event registration are responsible for cancelling all travel and accommodations with their carrier and the hotel

Please note that the travel scholarship is intended for reimbursement for expenses incurred to attend the Women InGovernment Leadership & Innovation Summit in San Antonio, Texas. In the event of conference cancellation due to circumstances beyond the control of Women In Government, WIG will not be responsible for registrants' costs associated with the cancelled event.
