HELP GUIDE



This document will guide you through creating an Apple Developer account. Apple charge an annual fee of \$99 USD (£79) which is paid directly to Apple. This cost is not included in our pricing.

Please note that you will need to provide us with your account login details so we can handle the submission process on your behalf.

- 1. Create your Apple Developer Account here: https://developer.apple.com/programs/ios
- 2. Click 'Enroll'.

3. Read the information provided and click '**Start Your Enrolment**'.

Section Enrolling as an Individual

If you are an individual or sole proprietor/single person business, sign in with your Apple ID to get started. You'll need to provide basic personal information, including your legal name and address.

Enrolling as an Organization

If you're enrolling your organization, you'll need an Apple ID as well as the following to get started:

A D-U-N-S® Number

Your organization must have a D-U-N-S Number so that we can verify your organization's identity and legal entity status. These unique nine-digit numbers are assigned by Dun & Bradstreet and are widely used as standard business identifiers. You can check to see if your organization already has a D-U-N-S Number and request one if necessary. They are free in most jurisdictions. Learn more >

Legal Entity Status

Your organization must be a legal entity so that it can enter into contracts with Apple. We do not accept DBAs, Fictitious Businesses, Trade names, or branches.

Legal Binding Authority

As the person enrolling your organization in the Apple Developer Program, you must have the legal authority to bind your organization to legal agreements. You must be the organization's owner/founder, executive team member, senior project lead, or have legal authority granted to you by a senior employee.



4. Here you will be prompted to log-in either by using your existing Apple ID, or creating a new one.

We strongly suggest creating a new account with a unique password for your developer program as we will need access to your account.

- 5. If you select '**Create Apple ID**" simply follow the account creation steps.

 Once you have agreed to the Terms & Conditions, we recommend selecting the 'Individual' entity type, as it is much easier and quicker to set up.
 Company accounts require you to confirm legal and company details with Apple and can take 2-3 days.

The main difference between each account is the individual account displays your personal name as the "developer name" in the App Store. If you wish to have your company or organisation name as the developer name, you'll need to create a company account.

When you're ready, **select your preferred** account type.

8. Note: If you are enrolling as an Individual, skip this step!

This page asks you to confirm that you have legal authorisation to bind your company or business to Apple's legal agreements.

If you need to supply a contact to verify this, enter their details (e.g. the company owner or legal representative).

If you are the owner or founder of your company or business, choose the first option.

When you're ready, scroll down to '**Organisation Information**'.

9. Note: If you are enrolling as an Individual, skip this step!

You'll now need to enter some details about your organisation. Ensure you enter all information correctly.

Click '**Continue**' once you have filled in all the fields.
