HOLD HARMLESS WAIVER

For and in consideration of being permitted to participate in this activity, organized and sponsored by Harvest Christian Fellowship, the undersigned hereby voluntarily forever releases, discharges, waives, and relinquishes any and all actions or causes of action for personal injury, property damage, or wrongful death, occurring to the participant arising out of the participation in Harvest Sports or any activities incidental thereto: wherever or however the same may occur and for whatever period said activities may continue, and the participant or parent/guardian of participant does for himself/herself, his/her heirs, executors, administrators, or assigns hereby release, waive, discharge, and relinquish any action or causes of action, aforesaid, which may hereafter arise for himself/herself and for his/her heirs, executors, administrators or assigns. These shall not prosecute or present any claim for personal injury, property damage or wrongful death against Harvest Christian Fellowship (hereinafter referred to as "HCF") or any of its officers, agents, servants, or employees for any of said causes of action including, but not limited to, losses caused by the passive or active negligence of HCF.

The participant or parent/guardian of participant acknowledges, understands, and assumes the risks inherent in recreation activities, and that said activities entail risks of physical injury to the participant's person and property and the participant has full knowledge of said risks.

The participant or parent/guardian of participant acknowledges and understands, and assumes the risk, if any, arising from the conditions of the various recreation facilities, basketball courts, and adjacent school, or park grounds and parking lots; and acknowledges and understands that this HCF waiver includes, but is not limited to, any action or cause of action arising from (1) the performance or failure to perform, maintenance, inspection, supervision, control, or security of said areas, (2) the failure to warn of dangerous conditions as existing on or near said locations, (3) any action by the spectators, (4) negligent supervision or selection of officials, spectators, players, or coaches, or (5) any hidden, latent or obvious defects or dangerous conditions existing on or near said locations.

The participant or parent/guardian of participant intends by this instrument to exempt and relieve HCF from liability for personal injury, property damage, and wrongful death caused to the participant by the passive or active negligence of HCF.
