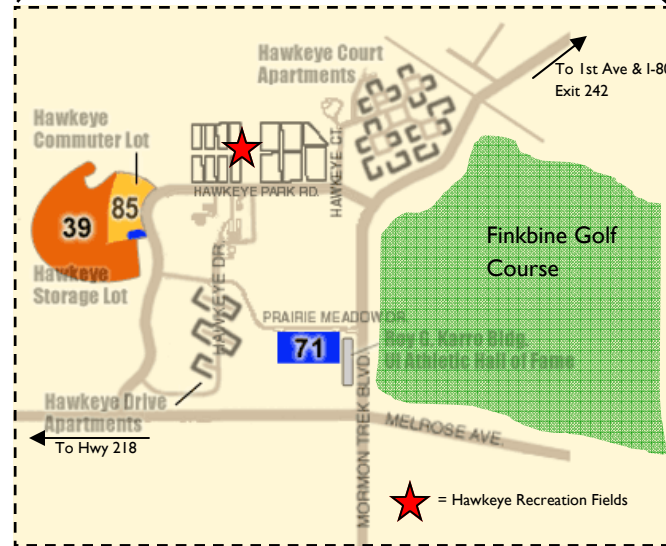
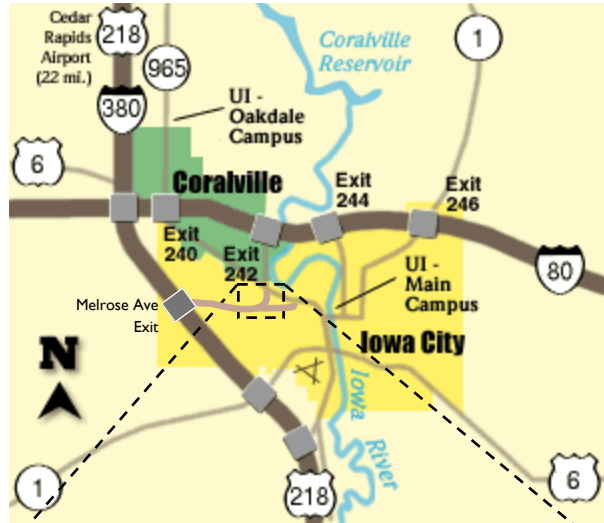

From I-80

I-80 Exit 242 1st Ave and head south on 1st Ave. Turn right on Hawkeye Park Road after crossing under railroad tracks. Sand courts are on the right.

From the North (Cedar Rapids area)

Go South on I-380/218 until 1 exit south of I-80. Take the Melrose Ave exit. Turn left and proceed approximately 1 mile to Mormon Trek Blvd. Turn left on Mormon Trek and turn left on Hawkeye Park Road. Sand courts are on the right.

From the South

Go North on 218 until the Melrose Ave exit. Turn right and proceed approximately 1 mile to Mormon Trek Blvd. Turn left on Mormon Trek and turn left on Hawkeye Park Road. Sand courts are on the right.

Tournament Format

- ◆ Registration begins at 8:30am; Play begins at 9am.
- ◆ One Champion will be crowned in each of the 4 tournaments: Women's Sand, Women's Grass, Men's Sand, and Men's Grass
- ◆ Matches are 2/3 games to 21 points; 3rd game is to 15 points if necessary; no point cap; switch sides in multiples of 7
- ◆ Net serve is in play
- ◆ All players are front row
- ◆ Must maintain serve rotation
- ◆ No open hand tips
- ◆ Block touch does not count in the 3 contacts
- ◆ Court size is 30'x30'
- ◆ One round of pool play—will seed for single elimination tournament bracket
- ◆ Tournament seeding based on head-head games, head-head points, total points
- ◆ USAV Domestic Competition Rules apply
- ◆ Prizes awarded to winning teams
