## **Key responsibilities**

Some of the key responsibilities for this role include:

- Having a technical understanding and delivering upon Council's asset management policies and strategies.
- Undertake asset and activity planning, follow standards and seek continuous improvement in activity management

- Develop and maintain a rolling threeyear programme of fully scoped renewal and capital improvement projects.
- Follow programmes and processes in place to continuously improve the lifecycle management of water, wastewater and stormwater assets and to enable the refinement and optimization of renewal programmes.
- Accurately capture asset attribute, performance and condition data in conjunction with the Three Waters Maintenance, Operations and Infrastructure Information Teams.
- Ensure appropriate activity management principles are applied to three waters assets, contribute to the development and management of continuous improvement programmes.
- Collaborate with the wider Asset Planning Team to support the development of Activity Management Plans (AMP's) for the water, wastewater and stormwater activities.
- Contribute to asset revaluation processes for the water, wastewater and stormwater activities.
- Maintain risk and criticality-based planning approaches for the various asset classes.
- Assist with implementing and supporting the continuous improvement of our Asset Management Systems.











- Utilise corporate systems to ensure asset and activity management decisions are data driven.
- Follow strategies and objective for asset management practices to maximise Asset Management Maturity as described by IPWEA IIMM.
- Help ensure that the wider Three Waters team focuses on the delivery of a quality service which meets or exceeds the agreed LOS and KPI's.
- Ensure compliance with Council's management policies.

- High level of computer literacy, particularly in Microsoft Office applications such as Excel and Power BI.
- Flexibility, initiative, quick responder with an ability to remain calm under pressure and when situations change.
- Exceptional oral and written communication skills, with the ability to clearly communicate technical and standards information in a clear manner.
- Demonstrated management and organisational skills and capacity to deliver high quality outcomes within agreed timeframes.
- Ability to analyse complex problems and identify solutions for their resolution.
- Ability to operate independently, anticipate requirements and monitor workloads.
