

Public Notification of Notice of Requirement:

Rotokauri Strategic Infrastructure (RSI)

PUBLIC NOTICE IN ACCORDANCE WITH SECTION 95A OF THE RESOURCE MANAGEMENT ACT 1991 (THE RMA) - NOTICE OF REQUIREMENT

Hamilton City Council (in its role as a territorial authority) received a Notice of Requirement (NOR) from Hamilton City Council (in its role as a requiring authority) to designate land for the construction, operation and maintenance of the Rotokauri Strategic Infrastructure network.

The Notice of Requirement is outlined below:

Requiring Authority	Hamilton City Council (Infrastructure and Assets)
Description	The NOR pursuant to section 168A of the RMA is to designate land for “Strategic Transportation and Three Waters Infrastructure” purposes for the construction, operation and maintenance of a multimodal transportation and infrastructure corridor to facilitate planned growth within the Rotokauri Growth cell. This includes local, collector and arterial transport corridors as generally provided for in the Rotokauri Structure Plan.

All submissions must include: Name, postal address, email address, phone numbers, if you support or oppose with reasons, the recommendation or decision you seek and whether you wish to be heard and/or attend a hearing, and whether or not you are a trade competitor.

A person who is a trade competitor may only make a submission if that person is directly affected by an effect of the Rotokauri Strategic Infrastructure that:

- Adversely affects the environment; and
- Does not relate to trade competition or the effects of trade competition.
