## RESOURCE MANAGEMENT ACT 1991 DIRECTION #13 INDEPENDENT HEARING PANEL

**Purpose**: The purpose of Direction #13 is to correct an error in Direction #11 relating to the Waikato Racing Club Incorporated (WRCI).

## Introduction

- 1. Under Direction #11 the Panel, among other things, struck out the rezoning submission from WRCI as being out of scope of PC12.
- 2. By memorandum dated 30 May 2023, counsel for WRCI correctly noted that its submission on PC12 encompassed more than the rezoning request and sought a direction that certain submission matters were in scope and could proceed.
- 3. Ms Mackintosh cited WRCI's submissions on the following provisions:

- 4. Having reviewed the original submission (#266), the Panel confirms that WRCI's submissions on the provisions identified in paragraph 3 above are in scope and can proceed to be heard.
- 5. The Panel notes with respect to sub clause (r) in paragraph 3 above that the reason given in the submission relates to the rezoning matter struck out but that the relief sought appears able to stand aside and alone. That matter is to be addressed accordingly.
