Further to your information request of 16 February 2020 in respect of the Waikato expressway interchange, I am now able to provide Hamilton City Council's response.

You requested:

Can someone in the council please tell me why work hasn't started on the interchange city side of Ruakura when the work was supposed to be finished this year.

Our response:

- 1. The Ruakura Interchange is an integral part of the Waikato Expressway being delivered by Waka Kotahi NZ Transport Agency.
- 2. The Ruakura interchange and the links to the city network, is being undertaken as a collaboration between The Transport Agency and Ruakura Ltd, the developer of the Ruakura Inland Port.
- 3. You are advised to put your requests to the Transport Agency direct. The contact person is Bruce Waugh (bruce.waugh@nzta.govt.nz)
- 4. The Agency has indicated publicly that the completion date for the Waikato Expressway will be late 2021.
- 5. HCC notes that the Expressway Ruakura Interchange eastern link from Morrinsville Road (State Highway 26) is largely complete and that the actual interchange is also largely complete.
- 6. The component of the interchange that has not yet started is the Ruakura Interchange western link to join the city transport network.
- 7. HCC is in discussions with both parties on how it can assist in delivering this western link.

I called once again on Friday asking about the Waikato expressway Ruakura city side interchange. I note no work has started on the building of this. I started asking the question in September 2019.

When I first called I was told that the Hamilton city council was having nothing to do with the interchange and that it was a NZTA job. If I hadn't just gotten off the phone to the NZTA people I probably would have accepted this. It took 3 days to find someone who new about the interchange. And I was told that the council was working on it. I did explain at the time that the road was supposed to be completed by 2020.

Which has now been pushed back to 2021.

However the road was supposed to be completed this year.
