Further to your information request of 11 June of which we provided a response to Question 1 on 2 July 2020, I am now able to provide Hamilton City Council's response to Question 2.

You requested:

Please provide a list of capital projects and their \$value not approved in the LTP since 2005, whether they were approved by full council, a committee, or staff and the reason for their acceptance. Also advise when these projects were discussed with the whole community and the statistical results of the community consultation.

Our Response:

Your question has been interpreted to mean you would like Council to identify those capital projects that have progressed which have not been first initiated from a Long Term Plan process.

We have considered the request as it relates from 2014/15 which covers part of the 2012-22 Long Term Plan, the 2015-25 Long Term Plan and the 2018-28 Long Term Plan (to date).

In providing this information we have excluded programmes of work such as renewal programmes. By way of example additional assets are invariably added to renewal programmes of work based on continuous condition assessment. Any additions to these programmes are generally not significant.

We have confined our answer to key projects which have a material value.
