Further to your information request of 3 July 2020 in respect of Local authorities fuel tax payments, I am now able to provide Hamilton City Council's response.

Our response:

Please find the information you requested **attached**.

- We have provided information regarding payments of local authority fuel tax (LAFT) to the Hamilton City Council in the last two years which include details of the volume / quantity of petrol and diesel sold. The June 2020 data is not yet available. This will be available by the middle of August 2020.
- We can confirm that each of the fuel operators in the Hamilton City Council catchment area have submitted their monthly LAFT returns outlining the volume / quantity of petrol and diesel sold and paid the required LAFT on those sales in the last two years.
- We are not aware of any fuel operators breaching their obligations to pay LAFT to the Hamilton City Council in the last two years. All the fuel operators have paid on time.

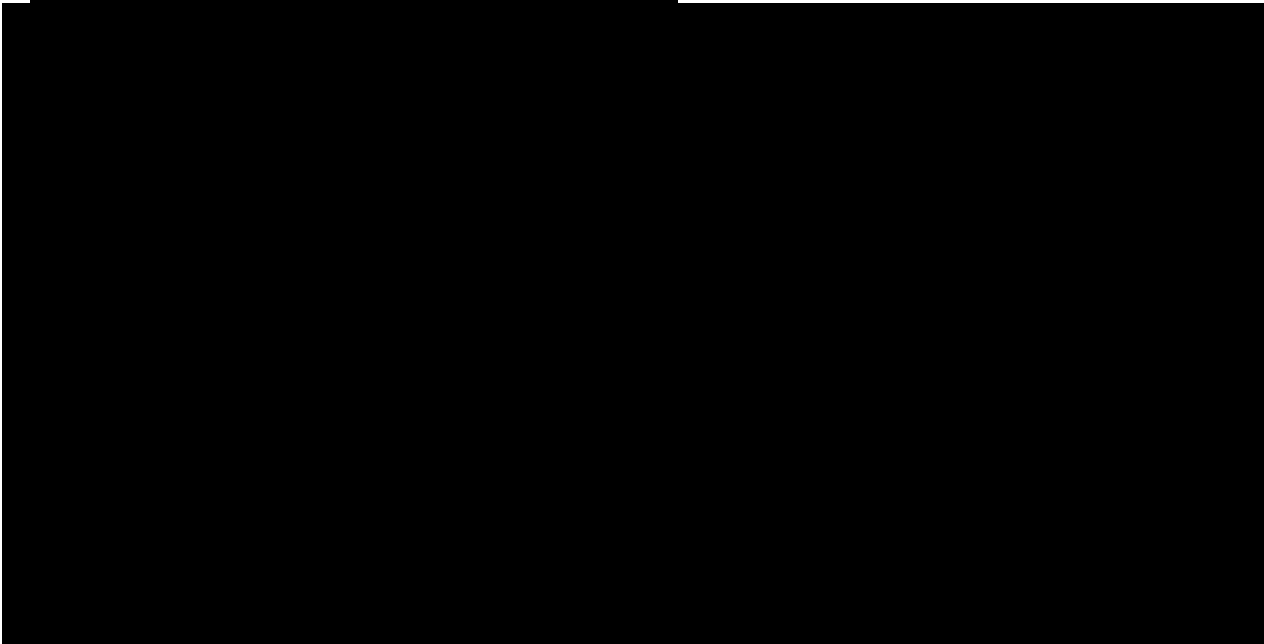
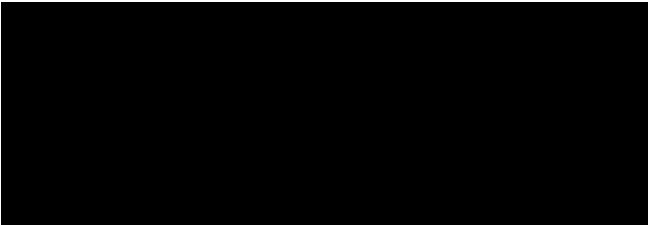
