Further to my email of earlier today relating to your request under the Local Government Official Information and Meetings Act 1987, I can advise that Hamilton City Council has had an opportunity to prepare the information you requested. As we have previously advised, the Act requires Council to balance the public interest in disclosing information against any interests in the information being withheld under a ground in the Act. Having now undertaken this balancing exercise, Council has determined in this case the public interest in disclosing the information outweighs the likely prejudice to the named businesses' commercial position.

Accordingly, Council has determined to release the information you have requested. We understand you have requested an interview with the relevant staff member. Our approach as a Council is always to support media where possible. However, at the same time we have to ensure the information we provide is accurate and fair to all parties. As such, we are responding to your questions about specific businesses in writing. Please find a spreadsheet attached.

Peter McGregor, Environmental Health Manager at Hamilton City Council, is happy to take part in an interview to answer your more general questions (copied below for reference). Peter is available tomorrow afternoon to speak with you by phone. In line with the above, should questions be asked about specific businesses, Council will be unable to provide an answer during the interview and will follow up afterwards, once the information has been identified and the balancing test under the Act carried out.
