I refer to your **information request below**, Hamilton City Council is able to provide the following response.

Please see attached the relevant correspondence. Please note that we have withheld some information from this response per <u>s7 of the Local Government Official Information and Meetings Act 1987</u>. We have done so on the basis that it is necessary to withhold this information:

- to protect the privacy of natural persons per s7(2)(a) of LGOIMA
- to protect information which is subject to an obligation of confidence and where the making the information available would be likely to prejudice the supply of similar information in the future and it is in the public interest that such information should continue to be supplied per s7(2)(c)(i) of LGOIMA

Chief Executive of Momentum, Kelvyn Eglinton, spoke on this issue in Public Forum at the Council meeting on 16 December 2021. See here the <u>minutes</u>, <u>agenda</u>, and <u>recording</u> of said meeting.

Furthermore there have been numerous occasions where people from the performing arts community – some wishing to remain anonymous – have indicated verbally to the Mayor and staff their preference for Founders to be removed in favour of other alternatives.

Dear Paula

The Waikato Regional Property Trust (WRPT) offers its appreciation for Hamilton City Councils partnership to develop the Waikato Regional Theatre.

The WRPT trustees are committed to the theatre project as a transformational attraction for the CBD, the communities of Hamilton and the Waikato, and the performing arts industry across the country.

We are therefore obliged to reluctantly express our concern over Council's decision to provide time, and therefore implied legitimacy, to an attempt to retain the Founders Theatre as a "Town Hall" and performance venue.

Retention of the Founders as any kind of event venue will create a significant challenge to the viability of the business plan for the Waikato Regional Theatre, given the feasibility report is based on the premise of providing for community events, which is part of the requirements stipulated by Hamilton City Council. The Regional Theatre is a central plank within the Central City and River Council strategies.

The feasibility of the new theatre's operations is predicated on its program including community events such as prize-giving's, graduations, and seminars and community performances – the very 'town hall' activities being proposed for Founders. This is not an issue of market competitiveness given the Theatre is not a commercial product and given Councils stipulation to provide Community access at lower than market rates and without operating grants from Council to cover such levels of service.

The Founders refurbishment proposal as a performance or Town Hall venue is a material compromise to Council's significant investment in the new theatre through its cornerstone funding and ongoing maintenance commitment. We reiterate – should Council wish to retain Founders for purposes other than a town hall or event venue then there is no issue from the WRPT perspective. Indeed the original proposal was to be a community office and support hub.

The Waikato Regional Theatre will be a critical element in the city's performance-facility ecosystem, which includes schools' auditoriums, The Meteor, The Academy of Performing Arts, Clarence Street and Riverlea. To effectively add a further event space to the city threatens the viability of the commercial venues amongst these facilities, which collectively already provide more than enough rehearsal spaces for local productions. Part of the WRT proposal is the development of the Performing Arts Strategy, funded by Momentum Waikato, to ensure a collaborative approach to facilities is developed. This was first signalled as a need within Hamilton City Council's Performing Arts Venue strategy when the Founders Theatre was operating at 36% capacity.

In answer to queries re future growth there is adequate capacity in venues across the city, when operating collaboratively as envisaged in the strategy above and given the Regional Theatre has the capacity and technology to rapidly turn over events and event setup.

By directly competing on seating capacity and events, resurrecting the Founders contradicts the very basis on which the Waikato Regional Theatre was devised in partnership by our respective agencies and has since been supported by partners and funders.

We would be pleased to expand on this further to Council and request an opportunity to meet with you at your convenience on this matter.

Kia ora koutou,

This email is on behalf of Creative Waikato in regards to Founders Theatre and the ongoing discussions around that space.

We are aware of the submissions being made from TOTI with regards to this space and their intentions for it.

With that in mind, we wanted to send this as a statement of our position:

- 1. We are fully supportive of the work and vision of the Waikato Regional Property Trust in regards to the development of the new Waikato Regional Theatre with the support of Momentum Waikato. Creative Waikato played an important part in the wide community consultation and engagement about this project, and still stand behind all that work in regards to the WRT, including its location, design, and structure as a community-led asset for our city and region.
- **2.** We are currently undertaking the development of a Waikato Performing Arts Strategy with community consultation. This project has been developed at the request of Momentum Waikato with a vision to have greater understanding and future vision for the whole performing arts ecosystem in Hamilton and the Waikato region. This includes the intersection between the various venues, theatres, and performance spaces. It also looks at pathways, development, innovation, and wider community involvement in all of our creative spaces. This strategy is working with a vision for the spaces that are functioning and how they best serve the community.
- 3. If any element of the Founders site is to be maintained, we stand by our submission in the last open community consultation around keeping the newer dressing room wing to work as a stand alone building to be used by the community for rehearsal space. And then removing the rest of the building to convert into green space ideally with an outdoor stage as was outlined in the HCC proposed concepts for the green space (option 2). This seems a cost-effective solution, and one that would serve our communities of practitioners in a meaningful way as part of the performing arts ecosystem.

It is noted that the community was also 84% in support of an option to convert the site to a multipurpose park. This use of the space would continue to serve the performing arts community that was the original reason for the space, but would also positively contribute to the vision for the development of performing arts in our city in alignment with the work being done by our existing spaces, as well as the new WRT.

4. Creative Waikato are passionate advocates for art, culture and creativity in our region, and are, in principle, supporters of new opportunities for creative activity to take place in our city. But this view has to come with a realistic understanding of where the most impact can be made from civic investment in the sector. Therefore, we see that if there was scope for more civic investment in the arts, this could be better served by: supporting current arts infrastructure; enabling more large-scale creative activities to take place in our current spaces; and, creating a long-term arts fund for the community.

We are very happy to meet with HCC to talk more about this as required.

As a theatre user, creator, producer, supporter and audience member, (including as a founding and continuing trustee of the One Victoria Trust, and Bold Theatre Trust) I am extremely supportive of the Waikato Regional Theatre including its location, design, and structure as a community-led asset for our city and region.

I also support the existing theatre spaces including Meteor, Riverlea, Clarence, the Place, and the Academy.

I don't understand TOTI's proposal as it is lacking in any detail, and have not (via BOLD or the Meteor) had any approach from TOTI to discuss or support the proposal.

Further, I don't see why HCC would go against the 84% majority of submitters to the latest feedback (I say latest, as there were previous consultations) who favoured the option to remove the theatre and create a multi-purpose park.

Greetings, all.

To keep you up-to-date on the Founders Theatre rejuvenation project - to be considered by the council's <u>Community Committee 9:30am Tuesday 26 April</u>. This follows our briefing of the mayor & co 24 March, then all councillors 5 April. Next Tuesday's committee meeting will have the usual <u>Public Forum</u> at the beginning. We will book in for a slot. <u>Please let me know</u> if any of you also want to have a say. It is open to anyone interested, and we have a number of supporters keen to participate.....

Further background:

1. Attached is the committee agenda item and Management's recommendation against our project. Included in this attachment is our Powerpoint pp36-41, Business Case pp42-48, our attachment 1 (Quantity Survey estimates) pp49-53, and attachment 2 (our summary of usage options) pp54-55. NB these page numbers are at the bottom right corner of the pages (agenda total 280 pages)

Sean's report (the agenda item) is unclear on some aspects: Paragraphs 4-5 - TOTI's submission was NOT recognised by council until 24 June 2021 (last year) and then we were given only six months (in a pandemic), then the extension until 31 March this year. We sought the two recent briefing sessions in the hope of more time for councillors....

Paragraph 8 "Management have little confidence in the TOTI proposal"...and seek demolition of the theatre. This is the clear message.

<u>Paragraph 20 - this 'range of conditions'</u> is the 'management viewpoint'. We are surprised at some of these conditions and the reference to city theatres. Is this overkill? and Why? If our plan dosn't work out, then they could revert to demolition.....

Responses? .

Our view is simple. And commonsense. (Refer p 34 for HCC's budget) Why spend a million dollars of public money to demolish a civic building when it can be economically rejuvenated 'for the community by the community'. We had been told that building ownership transfer was not an option

Thanks for the presentation today which drew a lot of discussion. We are now going ahead with the formal paper to go to Cr Buntings Community Committee on Tuesday 26 May. My draft deadline for the paper is the end of this week. The paper will be considered in open session and will include your submission and a copy of the PPT slides you presented today. Once this has been cleared for circulation we will forward it to you.

If you wish to make a further presentation to the meeting in the public forum just let our Governance team know.

Essentially I have been asked to present two options.

a. Decline the TOTI proposal and proceed with the West Town Belt plan for the site.

Or

b. Enter into a conditional agreement with TOTI to confirm HCC's acceptance of the plan and to establish a gift of the building effective 01 July 2023 to the new Trust subject to a range of conditions.

I have yet to flush out the full proviso's of the agreement and correct wording on what those conditions will be but, they will be about satisfaction of a full and final business case including a risk and risk mitigation framework, an independent evaluation the proposed budget within the business case, written confirmation of those organisations who will partner in the plan, written confirmation from each of the funders (contributing the \$10m capital costs needed and operating cash requirements) and confirmation of the new Trusts constitution, appointment process, inaugural trustees credentials etc. This is no different to our process with other Theatre gifting by the city. I expect this would all need to be satisfied by the end of the 2022 calendar year.

It is important to note that Council must have the fullest possible confidence that your proposition will work before making any final commitment and I expect your funders will understand that. You should know that there was some concern, which I shared, over how robust the budget expectations were on all fronts and if option B is approved there will be detailed scrutiny over the numbers and TOTI's ability to deliver. The outcomes you plan to deliver for the betterment of the city are to be applauded however we must do all we can to obviate the risk of failure for all parties concerned.


