I refer to your **information request below**, Hamilton City Council is able to provide the following response.

Your Request 1:

I observe the recently published Annual Report for 2021/22 shows total DC revenue of \$27,062K (refer to note 9 on page 170 of the report). This figure is considerably less than the DC revenue for 2021-22 set out in the table previously provided. That being total DC revenue for 2021-22 sums to \$28,658K. Obviously the information provided in either the annual report or the table is erroneous. Can you please advise where the error is located and what needs to be done to correct it?

Our Response 1:

The Annual Report figure is correct. The discrepancy was due to a data query issue used to

compile the information provided in the LGOIMA response.

Your Request 2:

I also observe the 2021/22 Annual Report makes no reference to DC revenue attributable to community infrastructure (CI). Was there no DC revenue for CI actually generated in the last financial year?

Our Response 2:

Yes, there was DC revenue for CI generated in the last financial year.
