Key Messages and Recommendations

- 1. Hamilton City Council staff support the **Election Access Fund's** purpose and proposals.
- 2. The Electoral Commission should extend the Fund's provisions to include those with disabilities seeking selection to be a candidate, and campaigning as a candidate in local authority elections.
- **3.** We also request that any policy development consider the need for funding and practical arrangements required once a disabled candidate is elected.
- **4.** We support establishment of a Steering Group by the Electoral Commission that is responsible for developing and setting up key aspects of the Election Access Fund e.g., developing policies and processes for ongoing administration of the Fund, including receiving and assessing applications.
- **5.** Given the range and diversity of issues for disabled people, we would ideally like to see more than one disabled person on the Steering Group.

Introduction

- **6.** Hamilton City Council staff appreciate the opportunity to make a submission to the Electoral Commission on the **Election Access Fund**.
- 7. Overall, we support the purpose and proposals outlined in the Election Access Fund to support disabled people to stand as candidates in parliamentary general elections and by-elections.
- **8.** This will assist in reducing cost barriers faced by disabled people by covering disability-related costs which non-disabled candidates do not face.

Extend Fund to Candidates in Local Authority Elections

- 9. While Hamilton City Council staff are fully supportive of the Election Fund being established, we recommend that the Electoral Commission extend the Fund's provisions to include disabled candidates who wish to seek election in local authority elections i.e., the Fund to cover expenses for those disabled people seeking selection to be a candidate, and campaigning as a candidate.
- **10.** We note that expenses incurred could cover aspects such as paying for a support person, sign language interpreters, or accessible transport to events or meetings.
- 11. We also request that any policy development consider the need for funding and practical arrangements required once a disabled candidate is elected. For example, funds or allowances through the Remuneration Authority to cover accommodations required for their specific needs; funding for the local authority to ensure equal access and participation in all democratic processes, meetings, etc.

Steering Group to Establish the Election Access Fund

12. We support the establishment of a Steering Group (comprising senior staff from the Electoral Commission, an advisor from the Office for Disability Issues and a member from the Disabled People's Organisations Coalition) by the Electoral Commission that is responsible for setting up the key aspects of the Election Access Fund. However, given the range and diversity of issues for disabled people, we would ideally like to see more than one disabled person on the Steering Group.

13. We note that this initial stage in the process will include developing policies and processes, consultation, raising awareness, providing information in alternate formats, and setting up processes for ongoing administration of the Fund, including receiving and assessing applications.
