

# HANDBILL DISTRIBUTION



Tampa Police Department Handbill Distribution Investigations:



- A person or business who wishes to make a complaint will need to complete a Handbill Distribution Form, which is attached and can be located on the TPD Website at <a href="https://www.tampa.gov/document/handbill-distribution-investigation-complaint-21266">https://www.tampa.gov/document/handbill-distributioninvestigation-complaint-21266</a>
- After completing the form, the complainant can contact TPD communications at 813-231-6130 and request an officer to respond to initiate a report, collect the forms and all evidence supporting the offense.
- Upon a TPD officers' response to the hotel/business, the officer will collect the form and at least one of every type of handbill which will be scanned to the report and entered as evidence.
- The report will be routed to the department's Criminal Intelligence Bureau (CIB) and assigned to the public nuisance officer (MPO Ferdinand Barbosa, Jr <u>ferdinand.barbosa@tampagov.net</u>).
- The assigned CIB officer will generate a letter for the business identified as the sender of the handbills.
- Businesses which have been previously warned may have direct charges filed against the business (the business owners).



#### RE: Notice of Apparent Violation of Handbill Distribution Laws

#### Dear

This office has received complaints from the Hillsborough County Hotel and Motel Association that many of their members have found handbills distributed from your establishment that appear to violate Florida Statute(s) and Hillsborough County Ordinance(s). As violations of these laws provide criminal penalties, we will review such cases for criminal prosecution. This notice is being served on you as the owner, manager, or person responsible for the business that has been advertised on handbills that have been distributed without permission.

This letter serves as written notice of an apparent violation of handbill distribution law(s). The Hillsborough County Code of Ordinances and Laws prohibits the illegal distribution of handbills on private property without permission. Specifically, it provides:

#### Sec. 36-137. - Acts prohibited.

- (a) It shall be unlawful for any person to deliver, distribute or place, or attempt to deliver, distribute or place, handbills on private property upon which is posted a reasonably conspicuous sign reading "No advertising" or "No solicitation."
- (b) It shall be unlawful for any business advertising by means of handbills to direct, encourage or allow any person, employee or independent contractor distributing handbills on behalf of the business to deliver, distribute or place handbills on private property upon which is posted a reasonably conspicuous sign reading "No advertising" or "No solicitation."

Additionally, section 509.144, Florida Statutes, prohibits the illegal distribution of handbills at or in a public lodging establishment without permission and it further provides:

- (2) Any person, agent, contactor, or volunteer who is acting on behalf of a person, business, company, or food service establishment and who, without permission, delivers, distributes, or places, or attempts to deliver, distribute, or place, a handbill at or in a public lodging establishment commits a misdemeanor of the first degree.
- (3) Any person who, without permission, directs another person to deliver, distribute, or place, or attempts to deliver, distribute, or place, a handbill at or in a public lodging establishment commits a misdemeanor of the first degree.

Business owners, managers or operators are responsible to ensure handbills advertising their business are not distributed at local lodging in violation of the laws. Future distribution of handbills in violation of the law(s) could result in criminal charges brought against any person that violates these laws.




# **2022 HOMELESS PIT COUNT**

The Continuum of Care conducts a thorough count of the homeless population to measure the extent of homelessness, and the 2022 Annual Point-in-Time Count took place on February 24th. The pandemic continued to challenge our community but, thanks to our amazing community partners, our CoC was able to sample parts of the county and extrapolate a valid estimation of how many homeless neighbors we have in our community.


