

# HEPPNER – A Bit O’ the Irish – Yxxxx - 10k – 1A

These instructions may be used only upon registration at a currently sanctioned IVV/AVA Event

1. From the Street, **Enter** Heritage Park and then **RIGHT** on the Center pathway toward the bridge
2. **CROSS** the Bridge and Veer Left toward the drive through. Take in the City Map to your left.
3. Facing the City Map, **LEFT** along W. Linden Way/OR-207 to Church St.
4. **LEFT** to Cross W. Linden Way/OR-207
5. **RIGHT** on W. Linden Way/OR-207 all the way to E. May St.
6. **LEFT** on E. May St. which curves Left, passing by the Morrow County Courthouse, where it becomes N. Court St.
7. **CONTINUE** on the Left side, facing traffic, as the road curves 90-degrees, passing the Fairgrounds.
8. **RIGHT and CROSS** Heppner Hwy at E. Fairview Way
9. **RIGHT** on E. Fairview Way which becomes Barrett Blvd.
10. **LEFT** on N. Gilmore St.
11. **CONTINUE** all the way to the end intersection with SE Hagar St.
12. **CROSS and LEFT** on SE Hagar St. to Alfalfa St.
13. **RIGHT** on Alfalfa St, crossing the bridge, to Cowins St.
14. **LEFT** on Cowins St. to the pathway on the Right.
15. **RIGHT** up the path switchbacks to an intersection “Y”, “T”, ??
16. **RIGHT** toward the roadway, NOT toward the building
17. **RIGHT** on the roadway to the next intersection.
18. **SHARP RIGHT** and the road will curve to the Left becoming ~~S. Chase St.~~ Bruce Kelly Dr
19. **LEFT** at the first entrance into the Masonic Cemetery
20. **CONTINUE** to the first intersection.
21. **RIGHT** and continue around the Tree (Left or Right) to the next intersection.
22. **RIGHT** and continue to the exit.
23. **EXIT and LEFT** on S. Chase St. which curves Right
24. **RIGHT** on S. Chase St. to Cannon St.
25. **LEFT** on Cannon St. to S. Main St.
26. **RIGHT** on S. Main St. to May St.
27. **LEFT to CROSS** S. Main St. on W May St.
28. The street curves Right as Gale St.
29. **CONTINUE** on Gale St. to Water St.
30. **LEFT** on Water St. which becomes Willow View Drive.
31. Willow View Dr. makes an “S” curve up past the Morrow County Sheriff Building.
32. After the Sheriffs’ building, **CONTINUE RIGHT** up toward the School.
33. At the end of Willow View Dr., take the Middle choice and keep the school on your Right.
34. Pass the school and continue to a large intersection.
35. **STRAIGHT** on the middle road, Spruce Ln. to Fuller Canyon Rd.
36. **RIGHT** on Fuller Canyon Rd. to Riverside Ave.
37. **RIGHT** on Riverside Ave.
38. **CONTINUE** to the Heritage Park and **FINISH**.
