Week 8 Legislative Days 24-27

This week the Georgia General Assembly met Monday through Thursday for Legislative Days 24-27. The top issues for the week include a heated committee debate over an election omnibus bill, the Senate's passing of Alyssa's law, and updates on the Buckhead cityhood attempt. Things are ramping up at the State Capitol as the General Assembly prepares for Crossover day this upcoming Monday, March 6th. Election Omnibus Bill

Chairman of the Senate Ethics Committee Max Burns introduced a committee substitute to SB 221 that resulted in an omnibus election bill. While much of the bill is cleanup language submitted by the Office of Secretary of State, there were many new additions to the bill including: county election offices not being able to directly receive third party donations, chain of custody language, increasing punishments for election officers, and increasing the pixel sizes of scanned ballots, and other provisions. Over twenty amendments were added to the bill during committee, with the last being the most controversial; an amendment by Vice-Chairman Rick Williams that would strip ballot dropboxes all together from state code. This bill now sits in the Senate Rules Committee.

Buckhead Cityhood Update

The buckhead cityhood senate bill, SB 114, was heard on the senate floor on Thursday of this week. Much debate was stirred when Gov. Brian Kemp's office released a memo on Tuesday night outlining several key issues with the proposed Buckhead split from Atlanta. Executive council, David Dove, posed 11 questions to legislators that highlighted potential safety concerns, education concerns, and overall confusion that could result from the passing of SB 113 and SB 114. The bills currently do not outline how they will handle safety measures since a new city will fall out of the jurisdiction of the Atlanta Police Department. There is also no proposed plan for

Buckhead students that currently attend City of Atlanta public schools. In addition, the new City of Buckhead would contain land such as parks that would still belong to the City of Atlanta, creating 'Atlanta islands' within the new city. Ultimately, the Governor's opposition to these two senate bills significantly lowered the chance of Buckhead gaining cityhood. SB 114 did not pass the Senate floor.



Alyssa's Law

SB 32, known as Alyssa's law, passed the Senate floor this week with a vote of 42-10. Alyssa's law was written in response to the Florida Parkland school shooting that took place in 2018 and claimed the lives of 17 students. Alyssa was a 14 year old victim of the shooting, and her mom, Lori, has dedicated herself to school safety advocacy in her memory. Versions of SB 32 have been passed in several other states, and it is now being considered for Georgia law. SB 32 would mandate mobile panic alarm systems for every K-12 school in Georgia. This would allow teachers and education staff to call for emergency services quicker during emergencies with a panic button that they could carry on their person. Discrete and quick panic buttons are essential to reducing threats during active shooter emergencies as outlined in SB 32. The bill will advance to a House committee next week.

Sports Betting Integrity Act

SB 57, the 'Georgia Sports Betting Integrity Act,' died on the Senate floor on Thursday of this week. After much debate among the Senators, this bill failed to get a majority of the votes and will not advance to the House. Sports betting continues to be a controversial topic every year in the General Assembly, so there's a good chance its supporters will continue to work to get it passed.
