IN THE NEWS

University of North Caronlina at Greensboro

The (former) assistant women's basketball coach and (former) assistant director of the institution's nonprofit athletics fundraising organization participated in impermissible sports wagering activities. This included placing bets on games involving UNCG's men's basketball team. Several members of the athletic department staff, including the assistant director of compliance, failed to report the gambling violations. In addition to participating in impermissible sports wagering activities, the assistant coach failed to cooperate with the investigation.

PENALTIES:

- Three (3) years of probation
- 15-year show cause order for the former assistant coach
- 4-year show cause order for the former assistant director
- = \$15,000 fine

KEY TAKEAWAYS:

Student-athletes, coaches, conference office staff members, institutional athletics staff, and nonathletics institutional staff who have responsibilities within or over the athletics department (e.g., president, faculty athletics representative) may not bet on amateur, collegiate and professional sports in which the NCAA conducts a championship.

NCAA rules prohibiting sports wagering were established to protect student-athlete well-being and ensure the integrity of competition.

Institutions, current and former institutional staff members, and prospective and enrolled student-athletes of member institutions must instruct their legal counsel and/or other representatives to cooperate fully in institutional and NCAA investigations.

INSTITUTIONAL CONTROL AND SHARED RESPONSIBILITY

All individuals performing work for the University of Miami, regardless of full-time, part-time, or volunteer status are considered institutional staff members. Institutional staff members are obligated to comply with NCAA, UM and UM Athletics Department policies regarding collegiate athletics and our student-athletes. This obligation includes a shared responsibility to act ethically; a responsibility of not only self-accountability but also holding each other accountable for the high standards associated with honesty and sportsmanship.

As a University of Miami employee, we all share the responsibility of reporting unethical conduct and NCAA rules violations to ensure our NCAA eligibility as a Division I member-institution.

All violations are required to be submitted to Blake James or Craig Anderson



HEAD COACH ACCOUNTABILITY - The head coach is presumed to be responsible for the actions of all assistant coaches and staff members who report, directly or indirectly, to the head coach. An institution's head coach is responsible for promoting an atmosphere of compliance within his or her program and must monitor the activities of all assistant coaches and staff members involved with their program.



LEGISLATION EFFECTIVE AUGUST 1

2018-118 Awards, Benefits and Expenses - Medical Expenses - Mental Health Services and Resources. Requires that institution's make mental health services/resources available to student-athletes through the athletic department and/or the institution's health services or counseling services department.

2018-116 Recruiting - Unofficial Visit - Complimentary Admissions - Reserving Game Tickets for Additional Individuals. Institutions can now reserve tickets (in addition to permissible comp. admissions) for use of additional individuals accompanying a prospect during an unofficial visit, and for seat locations adjacent to complimentary seats being provided to PSA; the tickets must be purchased by the additional guests at face-value.

2018-115 Recruiting - Official Visit - Complimentary Admissions - Maximum of Five. Reduces from 6 to 5 the maximum number of comp. admissions that may be provided to a prospect and those accompanying the prospect on an official visit.

EXTRA BENEFITS



An extra benefit is any special arrangement by an institutional staff member or representative of athletics interest (booster) to provide a student-athlete, or their family and friends, with a benefit that is not generally available to a particular segment of the student body.

Common Examples of Impermissible Benefits:

^{*}In football, 2 of the 8 hours may include film review

^{*}In all other sports, 4 of the 8 hours may include skill-related instruction.

	CARA REMINDERS		
Preseason/ Vacation Practice	Daily and weekly time limitations do not apply to preseason practices occurring before the first day of classes or the first scheduled contest, whichever is earlier. All sports but football must take a day off during preseason and vacation periods.		
After Competition	CARA is prohibited after competition, even during vacation periods. For example, it is impermissible to make student-athletes participate in a punishment run after competition.		
8 - Hour Overnight Period	RARA and CARA is prohibited for an 8-hour period between 9:00 PM and 6:00 AM. An exception exists for a promotional practice (e.g., first practice of the season). Check with Compliance for other exceptions.		
CARA LOGS	A sport must begin recording CARA the first day of class (Aug 19), or the first day of preseason, whichever is earlier. CARA logs are due the last day of each month.



CONTACT PERIOD

Permissible for countable coaches to make in-person, off-campus recruitng contacts and evaluations.

QUIET PERIOD

Permissible to make in-person recruitnig contacts only on UM campus. No in-person, off-campus recruiting.

EVAL PERIOD

Permissible for countable coaches to evaluate PSA's at off-campus events but no in-person off-campus contact may occur.

RECRUITNG PERIOD MBB ONLY

Countable coaches may make in-person, off-campus recruiting contacts and evaluations.

DEAD PERIOD

In-person recruiting contacts are not permissible (on or off-campus. Evaluations, official, and unofficial visits are not oermitted.

RECRUITING SHUTDOWN

No form of recruitnia is permitted. Social media actions of approval are not permissible.
