Pursuant to NCAA Bylaws 11.4.2, 11.4.3, and 11.4.4, the University of Miami (UM) may not employ any individual associated with a basketball (men's or women's) or football prospective student-athlete (grades 9-12) in any athletics department noncoaching staff position for a two-year period before or after the prospective or current student-athlete's actual enrollment at UM.

An individual associated with a prospective student-athlete is any person who maintains, or directs others to maintain, contact with a prospective student-athlete, the prospective student-athlete's parents or legal guardians, or the prospective student-athlete's coach.

Individuals would be considered to be associated with a prospective student-athlete if their contact is directly or indirectly related to the prospective student-athlete's:

- Athletic skills and abilities; and/or
- Recruitment or enrollment at an NCAA institution.

An individual associated with a prospect could be any of, but not limited to, the following:

- Parents/Legal Guardians
- Coaches (high school/college)
- Personal/Skills Trainers
- Relatives
- Strength Coaches
- Advisors
