Please review the NCAA Bylaws below for your understanding:

13.6.7.4 Entertainment Expenses. [A] An institution may provide up to \$60 per person to entertain a prospective student-athlete, student host and up to four family members accompanying the prospective student-athlete during an official visit, which excludes the cost of meals and admission to campus athletics events. Additional individuals accompanying the prospective student-athlete on the official visit may pay the actual cost of entertainment arranged by the institution. The entertainment allowance may not be used for the purchase of souvenirs, such as T-shirts or other institutional mementos. The institution or representatives of its athletics interests shall not provide cash to a prospective student-athlete or the prospective student-athlete's family members for entertainment purposes. **[R]** (Adopted: 4/26/23 effective 7/1/23, Revised: 11/16/23)

13.6.7.5 Student Host. [A] A student host must be either a current student-athlete or a student designated in a manner consistent with the institution's policy for providing campus visits or tours to prospective students in general. **[R]** (Revised: 1/10/90 effective 8/1/90, 1/10/92, 1/9/96 effective 8/1/96, 10/28/97, 11/1/00, 8/5/04, 5/12/05, 4/27/06, 2/23/09, 4/26/12 effective 8/1/12, 6/16/15, 1/15/16 effective 8/1/16, 1/19/18 effective 8/1/18, 4/26/23 effective 7/1/23)

_____ I will **NOT** entertain or transport the PSA or their guests more than 30 miles from the University of Miami's campus, and I will **NOT** engage in or allow the PSA to engage in the following activities:

- Underage consumption of alcohol
- Use of drugs or sex-related activities
- Gambling or sport wagering activities
- Attending any adult entertainment establishments

_____ I will **NOT** allow recruiting conversations between the PSA and boosters, on or off campus.

_____ I will **NOT** create or use personalized recruiting aids, including decorations or special items featuring a PSA's name, image, or presence at any location during an Official Visit.
