

This form must be completed and approved prior to participation in an NCAA-certified basketball summer league. Consistent with NCAA Bylaw 17.5.8.1.4(a), student-athletes may compete only in leagues certified by the NCAA during the permissible summer period and with prior written institutional approval.

17.5.8.1.4 Exceptions. The following exceptions to the basketball outside-competition regulations are permitted (see Bylaw 17.36 for additional exceptions): *(Revised: 1/11/94, 1/14/97 effective 8/1/97, 10/28/99 effective 8/1/00, 2/24/03, 4/14/03, 4/24/03, 7/30/10, 1/19/13 effective 8/1/13, 6/26/24 effective 8/1/24, 1/15/25)*

(a) Summer League. A student-athlete may compete during the period between June 15 and August 31 or the institution's opening day of classes (see Bylaw 17.02.15.3), whichever comes earlier, on a team in a league certified per policies and procedures established and maintained by the Men's and Women's Basketball Oversight Committees. The student-athlete must receive written permission from the institution's athletics director (or the director's official representative) prior to participation in the league. If the student-athlete is transferring and has been officially accepted for enrollment in a second institution, and if the previous institution certifies that the student has withdrawn and does not intend to return to that institution for the next term, the written permission is to be obtained from the member institution to which the student-athlete is transferring. Under such circumstances, the student-athlete does not count on the summer-league roster as a representative of either institution unless the student-athlete has enrolled and attended classes during the certifying institution's summer term.
