

**FNBO KICK FOR CASH  
SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

**1. ELIGIBILITY**

Playfly Sports Properties, LLC (“PSP”) and First National Bank of Omaha (“Sponsor”) Kick for Cash Sweepstakes (the “Sweepstakes”) is offered and open only to legal residents of the United States who are 18 years of age or older. Void where prohibited by law. Employees of PSP, the University of Nebraska-Lincoln, and Sponsor, and their respective subsidiaries, affiliates, parent companies, sales representatives, agents, advertising and promotion agencies or any other agencies or entities involved with this Sweepstakes and members of their respective families (parents, siblings, children, and spouse and their respective spouses) and/or those residing in the same household (whether related or not) of each of the above, current and former (within the last five (5) years) high school and college football players and coaches, and any current or former professional or semi-professional football players. In addition, due to National Collegiate Athletic Association (“NCAA”) rules, “prospects” as defined by the NCAA, will not be allowed to take part in the prize. NCAA rules define a “prospect” as any individual who has started classes for the ninth grade, including individuals that attend a two-year college, until the individual officially registers and enrolls in a minimum full-time program and attends any term of a four-year collegiate institution’s regular academic year are not eligible to enter or win. By participating in this Sweepstakes, participants agree to be bound by these Official Rules. PSP reserves the right to disqualify from this Sweepstakes any person it believes has intentionally violated these Rules.

**2. PROMOTIONAL PERIOD**

Promotional Period begins on August 31, 2025 at 12:01 a.m. Central Time (“CT”) and ends on November 25, 2025 at 11:59 p.m. CT (“Promotional Period”).

**3. HOW TO ENTER**

To enter the Sweepstakes, participants must visit [huskers.com/fnbo-kick](https://huskers.com/fnbo-kick) or [fnbo.com/huskers](https://fnbo.com/huskers) and complete the entry page.

Once a participant has met the above criteria, you will automatically receive one (1) entry into the Sweepstakes. Limit one (1) entry per person regardless of method of entry. By entering, you acknowledge compliance with these Official Rules including all eligibility requirements. Entries generated by script, macro or other automated or mechanical means will be void. By participating in the Sweepstakes, entrants agree that PSP shall have the right to use all personal information provided to PSP in accordance with its Privacy Policy. By participating in the Sweepstakes and providing their email address and personal information, entrants hereby agree to PSP’s collection and use of their personal information and acknowledge that they have read and accepted PSP’s Privacy Policy.

You will also be given the option to receive marketing emails from the Sponsor. The Sponsor’s marketing emails are not related to entering the Sweepstakes, and whether or not you elect to

You can “opt-out” at any time from receiving marketing communications from the Sponsor by clicking on the “unsubscribe” link found in any such communication, then follow the instructions. Even if you do not opt-in to receive marketing emails from the Sponsor or if you do and later opt-out, Sponsor reserves the right to send you emails about the Sweepstakes. Using a browser or device not supported may prevent participation in the Sweepstakes. While all efforts are made to support current browsers and devices, new browsers and devices may not be supported if brought to market after the development of the Sweepstakes. Sponsor is not responsible for any browser or device supporting issues.

PSP is not responsible for lost, late, mutilated, misdirected entries or entries not received in time for the random drawing or for electronic, network or computer/scanner failures or malfunctions, or other technical errors of any kind.

#### **4. RANDOM DRAWING/ODDS**

Prior to every regular season home football game, PSP will select the Sweepstakes winner at random and will do its due diligence to ensure winner is eligible in accordance with the Sweepstakes Official Rules. PSP will communicate the winner to Sponsor on or around the Tuesday immediately preceding each regular season home football game. The odds of winning depend upon the total number of eligible entries received. The odds of successfully completing the field goal are dependent upon the skill of each selected entrant.

#### **5. PRIZE**

Seven (7) prizes (one (1) prize for each regular season home football game) will be awarded. Each prize will consist of the following for winner and one (1) guest: two (2) tickets, two (2) pregame hospitality passes, and two (2) pregame on-field access passes to the Nebraska Cornhuskers football game at Memorial Stadium in Lincoln, NE scheduled for the upcoming Saturday after the winner has been selected. In addition, the winner will also have a chance to kick a 30-yard field goal (ball will be placed on 20 yard line) to win \$5,000 (the “field goal prize”), which will be issued in the form of a check to the winner. Field goal requirements: (a) each participant must attempt the field goal kick on their own behalf (no one may attempt to kick the field goal on behalf of another participant); (b) athletic shoes and rubber cleats are permitted (boots, sandals, and shoes with metal spikes are not permitted); (c) each participant is required to use footballs and kickoff holder tees provided by Sponsor; (d) winners may not attempt any practice or warm-up kicks in any matter from any distance; (e) field goal attempt must be initiated from Sponsor’s designated hash mark on the field; (f) the football must go through the goal post on the fly, without bouncing or coming into contact with the ground or any item, person, or surface that would alter or enhance the flight path of the football (except the inside of the goal posts); (g) no aid of any kind may be given to any participant in this Sweepstakes; and (h) nothing may be done to the football, goal posts, participant’s footwear, or playing surface that would alter or enhance the participant’s chances of successfully completing the kick. If winner does not make the field goal, winner will receive a consolation prize of a \$100 Visa gift card and a Limited-Edition John Cook Bobble Head. Total Approximate Retail Value (“ARV”) of each prize is between \$310 and \$5,170 (depending on whether the winner makes the field goal), with a total ARV for all prizes of between \$2,170

and \$36,190. All prize details, including exact seat locations, to be determined in the sole discretion of Sponsor. Tickets are subject to standard rain-check policies and procedures. The terms and conditions of the tickets awarded as part of any prize will govern in the event the game is not played or held due to weather conditions, an act of God, terrorism, civil disturbance, work stoppage, local, state or federal regulation, order or policy, epidemic, pandemic and other issue concerning health or safety, state of emergency or any other reason. Each winner and his/her guests agree to comply with all applicable venue rules, regulations and health or safety policies in connection with the prize. Winner agrees that tickets are awarded pursuant to a revocable, nontransferable license that is personal to that applicable winner. Winner agrees that he/she shall not sell, resell, auction, barter, assign, exchange, place in commerce, transfer, give away, donate, or otherwise convey any ticket that is received as a prize. A violation of these restrictions shall revoke winner's license, and the tickets will not be honored. All costs and expenses associated with the prize acceptance and use not specified herein as being provided, including, but not limited to, lodging, transportation costs, meals, beverages, gratuities and other expenses incurred by accepting the prize are the sole responsibility of the winner. Potential winners will be notified on or around the Wednesday immediately preceding each regular season home football game and will be required to sign and return an Affidavit of Eligibility and a Liability and Publicity Release (where permissible) and W-9 prior to the 30-yard field goal kick attempt. If prize/prize notification is returned as undeliverable, such prize will be forfeited and an alternate winner will be selected. In the event of non-compliance with any of these requirements, prize may be forfeited and awarded to an alternate winner. Upon verification of eligibility, prize winner will be notified by e-mail, mail and/or phone regarding

the details of the prize. By accepting the prize, the winner agrees to accept the prize in the manner set forth by the PSP. The winner is responsible for all applicable federal, state, and local taxes on prize. The prize winner will be issued a Form W-9 and filed by Sponsor prior to the 30-yard field goal kick attempt, for income verification and tax purposes, for the retail value of the prize. The winner is advised to seek independent counsel regarding the tax implications of their respective prize winnings. By participating, entrants agree to be bound by these Official Rules. PSP reserves the right to modify this Sweepstakes in any way it deems necessary or appropriate.
