- Má thugtar cead scríofa do dhálta fón póca a thabhairt ar scoil, ní mór dóibh an fón póca a thabhairt don mhúinteoir ranga ar theacht chun na scoile dóibh.
- Tabharfaidh an múinteoir an fón póca / uaireadóir cliste ar ais don dalta ag deireadh an lae. Níl gléasra leictreonach ar nós cluichí leictreonach, Ipods, nó eile ceadaithe ag aon am.
- Ní bheidh an scoil freagrach as aon chaillteanas, goid nó damáiste a tharlaíonn d'aon guthán ná aon gléas leictreonach eile a thabharfar ar shuíomh na scoile.
- Cuirfear smachtbhannaí an Chóid Iompair i bhfeidhm ar aon dalta nach gcloíonn leis na rialacha seo.

Mobile Phone Policy

We wish to remind parents of our Mobile Phone Policy which has been sanctioned by the Board of Management and updated to reflect the latest guidelines in circular 0044/2025 by the Department of Education and Youth.

- **A pupil must have permission from the Principal to have a mobile phone in his / her possession.**

The Principal shall present the details to the Board of Management annually.

If a parent feels that his/her child needs to have a mobile phone for after school use you may contact the Principal to request permission and complete the Permission Form.

- The pupils personal mobile phone may not be used or accessed for the duration of the day. It is not permitted for a child to have a mobile phone in their school bag while at school, even if it is switched off.
- Pupils must switch off their phone before entering the school grounds and the mobile phone/ device must remain switched off on the school premises at all times.
- Pupils who have written permission to bring a phone to school must give the phone to the class teacher on arrival at school.
- The phone/smart watch will be returned to the pupil at the end of the school day. Electronic equipment such as games, iPods or other are not permitted at any time.
- The school will not be responsible for any loss, theft or damage to any technical device .
- Pupils not adhering to these rules will be dealt with according to the school Code of Behaviour.

Please note that if your child uses or attempts to access a mobile phone during the day , a parent / guardian is required to collect the phone/device from the school principal the following day.
