Partnership Agreement/Power of Attorney for the Subscription of Shares

Industrial Development Center West Sweden AB 556720-5132

During the financial year, the Board of Industrial Development Center West Sweden will continuously make decisions concerning targeted new issues of shares where you will be given the possibility to participate.

Companies will be given the opportunity to acquire an issue of shares at a

ratio value of SEK100, as below.

1 - 50 employees	40 shares
51 - 99 employees	90 shares
100 - 199 employees	170 shares
200 - 499 employees	210 shares
500 employees	410 shares

Trade union organisations and other regional stakeholders will each be given the opportunity to acquire an issue of 50 shares á a value of SEK100.

As long as the shares are owned, the shareholders shall pay an annual service charge to IDC West Sweden. The service charge is determined at the Annual General Meeting. IDC West Sweden reserves the right to take back shares without compensation in cases where the annual service charge is not paid within the specified time.

In cases of a possible resignation as partner in IDC West Sweden, the company will take back the shares without compensation. Alternatively, the shareholder can sell the shares to another company that is approved by IDC West Sweden. No other alternatives are valid according to this agreement.

Subscription period

Continuously during the subscription period stated in the agreement.

Settlement

Payment shall be made in connection with the subscription of shares, via an invoice, within the time stated in the agreement; however, at the earliest, 10 days from the decision.
