It is the responsibility of the Broker to verify the receipt of this form by calling the auction company at 615-896-5656 or 615-653-0080. **The participating Broker/Agent must be properly licensed by the State of Tennessee and must register and attend the auction with their client during any live auction or live & online webcast auction.** Oral registrations do not qualify for broker commission participation. **Commissions will not be paid to licensed real estate agents representing themselves or their immediate family members.**
