The participating Broker Agent must be properly licensed by the State of Tennessee and must register and attend the auction with their client during any live auction or live & online webcast auction. Oral registrations do not qualify for broker commission participation. Commissions will not be paid to licensed reaestate agents representing themselves or their immediate family members.
