# The Bridge - by Jim Combs

We're halfway through April and the weather is beautiful. We are truly blessed to live on Lake Murray and have the amenities that Yacht Cove has to offer. Most of the boaters have their boats in the water and gearing up for the summer. Don't forget about the boat inspections at the end of this month. We are currently having our residents update their records at the clubhouse in order to get the new gate cards and the pool FOB. It's a simple and fast process. We have a number of residents registered and a few more that need to get registered. The gate cards that you currently have now will expire in about 45 to 60 days. The pool Fob will get you into the pool area and it will also be used to gain entry into the clubhouse if renting it.

**Note from Yacht Cove Treasurer:** There have been questions regarding how the BOD \$150 assessment <u>now due June 1st</u> will be used. The total assessment amounts to \$59,700.00 (398 units x \$150). Based on past experience, we will likely collect from all but 10 units, which would leave us with \$58,200. By passing the assessment we are able to cover the \$25,000 deductible for the flood insurance damage, retain the \$25,000 increase in the 2016 roof budget, replace the camera system at the Clubhouse for \$3,000, and use the balance of \$5,200 towards new drainage systems, not covered by the flood insurance.
