## Request for derogation - European Championships of Small States of Europe

Dear EC members, Dear Colleagues,

We received a request from the European Judo Union, regarding a derogation of the Nationality rule (article 1.7 of the IJF SOR) for the European Championships of Small States of Europe, which will be held on 5-6 November 2022 in Luxembourg.

The EJU is asking if the following Nationality rule could be applied for this event:

"Nationality

These European Championships are open for all Small Member Federations of the European Judo Union (EJU), which are: Andorra, Cyprus, The Faroe Islands, Iceland, Liechtenstein, Luxembourg, Malta, Monaco, Montenegro & San Marino.

The competitors should be of the same nationality as the country, which enters them.

In addition, athletes without citizenship can participate, who have been resident in the country or, for Monaco, in the country or the border communes, which are Roquebrune Cap Martin, Beausoleil, La Turbie e Cap d'Ail, for at least three years without interruption at the date of the European Championships. Such athletes must present an official permit of residence, signed and sealed from the National Authority and a license of the national sport federation governing their sport in their country of residence for at least three years.

Important: IJF SOR, section 1.7 Athlete Nationality does not apply for this event and participation in this event does not affect nationality status of the athlete with regard to participation in official IJF and EJU events or change of nationality"

#### Waza-ari definition

To simplify the waza-ari scores, the definition of waza-ari is adapted.

Waza-ari criteria comprise landing on the upper side of the body at 90° or more to the rear, one shoulder and upper back, and landing simultaneously on two elbows or hands (waza-ari for tori and shido for uke).

## Mr. Epifanov's case: participation under the IJF flag

Dear EC members, Dear Colleagues,

We received the request regarding the participation of the athlete Mr. Platon Epifanov, in the Gori Cadet European Cup (29-30 April 2023), under the IJF flag.

The athlete Mr. Epifanov and his father emigrated from the Russian Federation to Georgia in March 2022. We have received a document proving that he currently resides in Georgia. The athlete intends to go to another country to pursue his studies.

According to the article 1.7.2 of the IJF SOR, "for events organised by the IJF or under its auspices, the IJF Executive Committee, in order to protect the interest of the athlete, can authorise that the athlete can compete under the IJF flag for any reason (for example: non-official refugee status of the athlete, non-recognition of the NOC by the IOC, suspension of the National Federation etc.)."

In view of the exceptional situation of the athlete, we propose to authorize Mr. Platon Epifanov to compete in the Gori Cadet European Cup (29-30 April 2023) under the IJF flag.

As the registration deadline for this event closes tomorrow, please send me your approval before tomorrow, Friday, April 14, 2023 before noon (12:00pm, Budapest time).

The Oceania Judo Union scheduled an elective General Assembly to be held on the 1st of April 2023 to elect a new President and a new Executive Committee.

In view of the difficulties encountered and the contradictory information we are receiving from various members of the OJU, we propose to conduct a professional audit before these elections.

In order to do this, we need to postpone the elective General Assembly of the 1st of April 2023.

In view of the proximity of these elections, we need to inform all the OJU member National Federations as soon as possible.

Consequently, please kindly send us your approval regarding the postponement of the OJU elective General Assembly and the conduct of the audit before tomorrow, Tuesday the 21st of March 2023, 12h00 pm (midday, Budapest time).

This decision is based on the Article 3.2 of the IJF Statutes:

"Statutes of Members

[...] In the event that a dispute or dysfunction is brought to the attention of the IJF President or another subject, which is detracting from the correct functioning of an IJF member structure, an IJF representative appointed by the IJF President can lead investigations which will be exposed to the IJF EC. The EC will be able to take any measure necessary for an appropriate functioning. The parties undertake to respect the IJF EC directives".

The International Judo Federation, as part of its «Good Governance» project in the sports sector, has set up a training programme for the benefit of national teams coaches.

This training is provided by the IJF Academy through either the qualification of Undergraduate Certificate as Judo Instructor (UCJI) or the Level 1 – Instructor course or the "Master coach". This initial course will be followed by a compulsory regular update of knowledge.

Following the EC meeting of October 4th 2022 in Tashkent, we kindly ask the validation of the EC members regarding the postponement of the obligation to obtain the required qualifications to January 1st 2024.

The «Master coach», which has enabled high-level skills to be recognised, is maintained, but will be given on an exceptional basis.

The obligation of IJF 6th Dan is replaced by having at least one IJF Dan."

#### Situation of Russian and Belorussian athletes

Dear EC Members,

I hope this email finds you in good health and spirits!

After our joint decision at the end of last year, to ask the Russian and Belorussian Judo Federations to not participate in IJF competitions until January, I would like to request your input regarding the way forward for the athletes from these two countries.

Judo has a special Olympic qualification system, that spans over 2 years and implies constant presence and performance of the athletes. We are fast approaching the half time of the qualification period and the lack of a clear decision to be followed by all sports, means that more time is wasted for these athletes and their qualification chances are decreasing every week.

In order to give at least a small fair chance to the athletes who are currently not allowed to participate in the qualification, I believe that it is time to allow them to return to competitions, in those countries where this is possible and in conditions of neutrality, as recommended by the IOC. Should there be a contrary decision later in time which will impact all sports and will ban these two countries from the Olympic Games, we can always remove them from the World Ranking List.

The professionalisation of sport in all areas is constantly developing. While top-level sport at the creation of the Olympic Games was completely amateur, sport has gradually become professional. Almost all Olympic athletes are now professionals. Technical staff has undergone the same development and today, with the increasing complexity of the organisation of sport, the compensation of leaders within the International Federations executives is becoming necessary.

Therefore, we propose for your validation the following statutory amendments:

Regulations for specific operations and departments of the IJF are governed by specific rules proposed by the specific departments, which shall be subject to approval by the EC, in particular: i) Disciplinary Code — IJF Disciplinary Code, ii) Event Standards — IJF Event Organization Guide, iii) Finance — IJF Financial Rules, iv) Ethics — IJF Code of Ethics. As may be required, additional specific rules may be established and submitted to the vote of the EC. The EC shall put the ratification of the decision to adopt or amendment of these specific regulations to the agenda of the next Congress".
