# Purposes for which your personal data are processed and legal basis for their processing

Personal data are individual details about personal or professional circumstances of a specific or identifiable natural person, such as your name, your address, your telephone number, your date of birth, your payment data and your IP address. Below we provide information about the processing and legal base of your personal data when using this website:

 Processing of personal data for purposes of registration, participation and execution of trainings, events or webcasts:

In order to participate in our trainings, events or webcasts and to be able to perform them, you must register for them. Therefore we process your personal data. These are your name and surname, business position, address, phone number and e-mail address. Legal basis for the processing of your personal data: Consent pursuant to Article 6 para. 1 lit. a GDPR. If you register for a training, event or webcast that is not free of charge, the legal basis for the processing of your personal data: fulfilment of a contract or pre-contractual action with you in accordance with Article 6 para. 1 lit. b GDPR.

#### • Processing of personal data for the purpose of sending information:

In the follow-up of training courses, events, webcasts or events on site, we process your personal data for purposes of one-time sending of information by post or e-mail. These are name and surname, company name, address and e-mail address. Legal basis for the processing of your personal data: Justifiable interest of the person responsible pursuant to Article 6 para. 1 lit. f GDPR.

#### • Processing of personal data for purposes of registration as a Reseller:

By registering as a Reseller, you provide us with personal data such as surname, company name, business position, address and e-mail address. Your data may therefore used for handling the collaboration and to contact you. Legal basis of the processing of your personal data: Fulfilment of a contract or execution of pre-contractual measures with you in accordance with Article 6 para. 1 lit. b GDPR.

#### • Processing of personal data for marketing or advertising purposes:

By registering to our newsletter (promotional information e-mail), we receive your personal data, more precise your name and e-mail address. Your data may therefore be used to send you marketing or advertising information. Legal basis for the processing of your personal data: Consent pursuant to Article 6 para. 1 lit. a GDPR.

### Processing of personal data for the purposes of your application for employment:

In order to be able to apply for one or more of our vacancies, we kindly ask you to send us your application documents to the E-mail address, provided on our website. For the purpose of receiving and processing your application, we process your personal data depending on the scope of your personal data submitted. Legal basis of the processing of your personal data: decision or justification of an employment relationship. You are welcome to submit your application documents in an access-protected file. Please contact us and let us know the information we need to view your application.

### Processing of personal data for the purpose on loan to a customer:

We process your personal data in order to process and execute your loan orders. These are your customer number, surname and first name, company name, address, and e-mail address. Legal basis for the processing of your personal data: fulfilment of a contract or execution of pre-contractual measures with you in accordance with Article 6 para. 1 lit. b GDPR.

 Processing of personal data for the purpose of investigation and prosecution of disruptions or abuses of our online services:

We investigate and track disruptions or abuses of our online offers or telecommunications services and equipment, for which we process your personal usage data. These are your IP address as well as the times of your visits to our website. Legal basis for the processing of your personal data: Justifiable interest of the person responsible pursuant to Article 6 para. 1 lit. f GDPR.

The provision of your personal data in the context of the use of our website is not required by law and only required for a conclusion of the contract, if this was named above for the respective purposes of the processing of personal data. Automated decision making, including profiling, based on your personal information processed through our website, does not occur.

# Categories of recipients of personal data

Your personal data processed on our website will only be forwarded to other recipients if this is necessary for the respective purposes of the processing of these personal data, or if we have entrusted further recipients with the performance of individual tasks or services. The categories of personal data recipients processed through our website are:

- Internal bodies involved in the execution of the respective business processes (e.g. purchasing, accounting, IT)
- Service provider for hosting, maintenance and administration of our website or our databases, currently: Infinigate Holding GmbH, Richard-Reitzner-Allee 8, 85540 Haar / Munich.
- Affiliated companies of our group of companies
- External service providers for direct independent support of the respective business processes (e.g. courier or delivery service provider, tax consultant, auditor)

The transmission of your personal data to recipients named above is based on your consent in accordance with Article 6 para. 1 lit. b European Data Protection Regulation, if it is necessary to fulfil a contract or carry out pre-contractual measures with you in accordance with Article 6 para. 1 lit. a GDPR due to the legitimate interest of the person responsible pursuant to Article 6 para. 1 lit. f GDPR, or in order to processing personal data pursuant to Article 28 (1) of the GDPR.

# Data transmission to recipients in a third country or to an international

### organization

We do not transfer any personal data processed via our website to a recipient in a third country or to an international organization.

## Duration of storage of personal data

Your personal data will only be stored for as long as their procession is necessary for the fulfilment of the purposes. Usually, this is as long as necessary to fulfil a contract with you. Apart from this, personal data processed via our website will be stored for a maximum of 48 hours and then deleted. However, due to legal, statutory or contractual retention periods some information must be saved for a longer timeframe. For example personal data with tax relevance usually over a period of 7 years, other personal data under commercial law usually over a period of 5 years.

### Information about your rights as an affected person

In general, and in relation to your personal information processed through our website, you may exercise the rights specified below.

- Right to access according to Article 15 of the GDPR:

You have the right to ask for information about your stored personal data and further information in relation to this personal data.

- Right to rectification in accordance with Article 16 of the GDPR:

You have the right to demand the correction of your incorrect personal data without delay.

- Right to cancellation in accordance with Article 17 of the GDPR:

You have the right to demand the immediate deletion of personal data concerning you, if it is within the legal restrictions.

- Right to restriction of processing in accordance with Article 18 of the GDPR:

You have the right to restrict the processing of your personal data.

- Right to data portability under Article 20 of the European Data Protection Regulation:

You have the right to obtain your personal data in a structured, common and machinereadable format.

### - Right of withdrawal in accordance with Article 7 (3) of the GDPR:

You have the right to withdrawal your consent of your personal data at any time in accordance with Article 6 para. 1 lit. A European Data Protection Regulation. The legality of the processing of your personal data carried out on the basis of your consent until your revocation is not affected.

#### - Right to object in accordance with Article 21 (1) of the GDPR:

In accordance with Article 6 para. 1 lit. e or f of the European Data Protection Regulation you have the right to object the processing of your personal data at any time.

### - Right to complain to a supervisory authority under Article 77 of the GDPR

If, as an affected person, you believe that the processing of your personal data is contrary to the European General Data Privacy Regulation, you have the right to complain to a supervisory authority, in particular in the Member State of residence, place of work or location of the alleged default infringement.
