ABSTRACT

Introduction: James V Forrestal Secretary of the Navy and First Secretary of Defense died at Bethesda Naval Hospital On May 22, 1949. It has been proven that Forrestal's death was a government sanctioned homicide although it was initiall attributed to a death by suicide. During Forrestals' brief stay at Hobe Sound right before his hospitalization at the Bethesda Naval Hospital, his personal diaries consistent of 15 loose left binders totaling 3000 pages were removed from his former office in the Pentagon and locked up in the White House, where they remained for a year. Forrestal's homicide have led to allegations that his objections to the creation of Israel might have been a factor in his homicide. **Objective:** The aim of this study is to prove that "Forestall was silenced because of his diaries "revealing extraordinarily sensitive secrets of the Second World War. **Method:** Through Google Scholar search we identified data associated with Forrestal's death to identify observations consistent with" Forestall was silenced because of his diaries" "and inconsistent with the alternative to project odds of certainty. **Results:** 16 observations are consistent with "Forrestal was silenced because of his diaries "and inconsistent with he was not indicates Forrestall was a victim of a homicide because of his diaries. Over many decades information has emerged proving that Forrestal's death was a government sanctioned homicide.^[1,2,3]

5. Forrestal was ordered to lie about 1,2,3,4.^[6]
6. Truman did not give written orders for Nagasaki.^[3,4]
7. Truman did not give written orders for Hiroshima.^[3,4]
8. Truman learned of the Nagasaki after the bomb was dropped.^[3,4]
9. Hiroshima was not necessary to end the war.^[4]
10. Nagasaki was not necessary to end the war.^[4]
11. Japanese POW Naval officers were silenced after interrogations.^[6]
12. Forrestal was ordered to lie about 11.^[6]
13. Forrestal's diaries were kept away from family for one year after his death.^[1,2]
14. No records of August 1-9 '1945.^[3,7]
15. Published diaries reveal evidence of misrepresentations to support the official claim of death by suicide contrary to overwhelming proof that he was assassinated.^[3,7]
16. Diaries contradict official claims of depression and suicide.^[3]
17. FDR was mentally incapacitated in the crucial days of the 2nd world war.^[8]
