INSTRUCTIONS FOR CONTROL 05/06/2018

Type approval requires the manufacturer's own internal quality control and the continuous external quality control carried out by an accredited inspection body.

Internal quality control

Internal quality control shall ensure that the certified product complies with the approval during its validity period. If changes that might affect the product's type approved properties are made in the quality or manufacturing of the type approved sanitary tapware, including installation methods and accessories, the manufacturer is obligated to provide advance notification of this to the issuer of the type approval and the third-party quality inspection body in writing.

Continuous internal quality control by the manufacturer must include at least the following:

- Acceptance inspection of materials:
 raw materials, fixing materials, seals, semi-finished products.
 <u>Scope</u>: Each batch received and all tests and inspections carried out are recorded; all detected deviations are recorded.
- Manufacturing process: moulding process, dimensioning, chrome plating, paint finish, product assembly.
 <u>Scope</u>: Continuous temperature monitoring once per shift. Visual inspection on all products.
- Functional properties:
 tightness, closing.
 Scope: all products must be verified in accordance to the test method stated in EN 817
- 4. Labeling of the product according to annex 2 of the type-approval.

 Scope: all products which are complying with the requirements of type approval shall be marked. Otherwise, the sanitary tapware cannot be marked.
- 5. Work instructions, work methods (i.e. delivery check incl. assembly and installation instructions). All changes made and their times should be recorded.

The manufacturer must preserve the documentation covering the records from the internal quality control for at least 10 years.

The manufacturer must have a persistent methodology for receiving and processing claims of defects.

External quality control

External quality control comprises a review of the manufacturer's internal quality control, and shall be performed once per year by an accredited inspection body according to the agreement no. 1168/2017

The following must be checked at least:

- 1. Quality Management System of the company
- 2. The kept documentation covering the records from the internal quality control
- 3. Receiving, handling and checking of incoming materials
- 4. Test report containing obtained results of functional properties
- 5. Calibration of the testing equipment used by the manufacturer
- 6. Conformity between produced products and the requirements of the type approval
- 7. Accidental release measures
- 8. Handling of customer complaints
- 9. Labeling of the products.

Annual report

The validity of the Type Approval requires that the production control is carried out and that the manufacturer annually fulfils the requirements for supervisory control.

The designated inspection body shall submit to Kiwa Sverige, department of product certification, a yearly report of the performed inspection.
