Additional Case Information:

Issues with delays in imports of eggs arriving on site during 2021 due to issues with lack of suitable flights from London to Edinburgh and courier delays. One whole batch arrived dead after 9 day delay in April 2021. Situation has improved now that shipments are going on flight to Edinburgh from London rather than waiting for courier collection. Next batch due on site on Thursday this week from USA.

Mortality peaks observed about a month after each input of ova due to egg picking and culls of deformities

Cress 50% currently being fed for gut fungus - associated mortalities low. Chloramine T also used, last treatment in July 2022.

Veterinary services now provided by Pharmaq Analytiq since company vet left in November 21.

Site thermometer used in line with biosecurity protocol.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as high. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted annually. The category of the site will be reassessed on a routine basis and updated as required.
