**Additional Case Information:**

No clinical signs of disease were observed during the inspection of the site. Fish were observed shoaling well and responding positively to routine feeding regimes. A 30 fish statutory test for VHS and IHN was conducted due to the water temperature being over 14 degrees. Due to the size of the fish at the time of sampling, the 30 fish tested were pooled into 6 samples.

Mortality has remained below the reporting threshold since the date of last inspection.

The site is due to fallow following a transfer of fish from all 8 stocked tanks to Geocrab Hatchery (FS0562) on 26/07/2024.

### Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected.

On this occasion, due to the water temperature being above 14°C, samples were taken to test for the presence of viral haemorrhagic septicaemia virus (VHSV) and infectious haematopoietic necrosis virus (IHNV). The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

### Samples

30 Atlantic salmon were tested for the presence of viral haemorrhagic septicaemia virus (VHSV) and infectious haematopoietic necrosis virus (IHNV). Samples were collected according to the table below:

The samples tested **negative** for IHNV and VHSV.

### Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be adequately maintained.

Mortality records were inspected and found to be adequately maintained.

No mortality levels exceeding the reporting criteria have been recorded since the last inspection.
