Site fallow since 27/07/2024. Disinfection completed 28/12/2024.

Cages were lifted out of the water by crane, then scraped and power washed to remove all organic material then disinfected with Virkon Aquatic (1%). Nets sent to Vonin (Scalpay) for cleaning and disinfection. Top nets disinfected on site.

Polar circles, workboat, and barge scraped, power washed and disinfected. Net washer also disinfected.

All feed pipes have been flushed through and disinfected.

Mortality uplift system pipes replaced.

Cameras and feed spinners removed, cleaned and disinfected.

Mooring cans cleaned and disinfected.

All ropes and PPE replaced.

Cages and equipment inspected as clean. Disinfection records inspected as satisfactory.
