Site had recently been stocked with ova from Ireland in week 4. Site had 2 inputs of ova in week 4 and 5. Ova were disinfected with buffodine upon intake. Site had noted that the first input appear to be poor stock noting slightly elevated mortalities whilst the second input have experienced less mortalities.

Site thermometer was used due to biosecurity risk. Site thermometers had certificates and calibrated annually. Thermometers were last calibrated 19/01/2025.

Ova were observed to be in good condition. Few number of dead ova were observed.

### Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

#### Records

The surveillance frequency category of the site was assessed as high. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted annually. The category of the site will be reassessed on a routine basis and updated as required.
