Stocked from Kames Hatchery in September 2024. Last movement offsite occurred on 23/10/2024 to Kames Bay East (FS0462).

Health surveillance occurs if there is an issue and when there are planned transfers.

Predation issues are not common in Loch Avich.

Four of the eight pens on site are wooden and not in use any longer. These are due to get removed in Spring 2025 and there are no plans to be replaced.

Fish were only observed in pens during feeding, showing a healthy feeding response. The water was too dark to observe the general population. No moribund or lethargic fish observed.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.
