Additional Case Information:

Only 2 tanks of RTR stocked. Fish were observed shoaling well and appeared to be in good health, no clinical signs of disease were observed. Remaining RTR will be harvested soon and sold locally. 1 Tank of Koi carp on site, all fish were observed and appeared to be in good health, no clinical signs of disease observed. Mortality has been very low since the site was last inspected, only 3 RTR mortalities have been recorded in the last 4 weeks and 0 Koi. No waste has been removed from the site since the date of last inspection, dead fish and waste are held in secure, sealed tubs on site. When full, waste is to be taken to landfill, meavag hatchery currently use the Bennadrone facility in Stornoway. No treatments have been conducted on site since the date of last inspection and no medicines are currently stored on site, although appropriate facilities are available if required.

Meavag fish farming are intending on applying for a change of species from RTR to SAL in the near future for the hatchery and 6 registered loch sites on the island. Management have been supplied with all relevant authorisation paperwork.

No movements of live fish on or off the site has occurred since the date of last inspection.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.

The site was also inspected in accordance with the Aquaculture and Fisheries (Scotland) Act 2007 with respect to section 5 regarding containment and escapes.

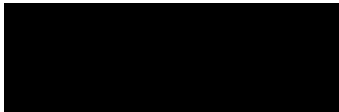
