Treatments: This cycle: Hydrolicer in January 2025 (3 cages) and Nov 2024 (whole site). Last cycle: Freshwater 2023, hydrolicer October 2023 (whole site), SLICE Sep 2023. Previous cycle: Thermolicer March 2023 and October 2022.

FMA not followed synchronously - risk assessment seen (dated Nov 2024).

Treatments: This cycle: Hydrolicer in January 2025 (3 cages) and Nov 2024 (whole site). Last cycle: Freshwater 2023, hydrolicer October 2023 (whole site), SLICE Sep 2023. Previous cycle: Thermolicer March 2023 and October 2022.

Health surveillance - 10th January 2025 - 3 pens checked, no significant results, some non-AGD lesions on the gills.

Remote inspection carried out 24/04/2025 with additional paperwork i.e. movement book seen on the day of inspection. Accompanied on site visit by the companies regional vet. Fish were shoaling deeper within the water column. Across all stocked pens, eight fish were observed swimming slower at the water surface by the net but all moved off when approached. Two fish were observed to have a couple of lesions/winter sores on their body and in pens 5 and 8 some fish were leaping out of the water. No sealice were observed while walking around the site. VMD samples were taken from pen 6 - two Caligus were on this fish and it appeared healthy both internally and externally.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.
